wristband policy at our pools. We are utilizing Tyvek (synthetic paper-like) wristbands this season to ensure community members and guests are paying for admission to the pool. The bathrooms at two of the three pools are outside the check-in areas, and the wristbands help Guest Service staff to visually monitor paid patrons. We have purchased the wristbands for the entirety of the summer and plan to continue the policy through this summer. We will be collecting feedback from community members throughout the summer and debriefing at the end of the season to determine the best course of action for next summer.
