

The Master Association Architectural Committee met again on March 12 to discuss the commercial vehicle parking rule for Ken-Caryl Ranch. At this time, the committee is not making changes to the rule. They are going to table further discussion until a new Community Administrator is hired to replace Jenny Bernal, who submitted her resignation. Residents can continue to submit feedback about the rule to me at victoriad@kcranch.org.

North American Development Group is moving forward with the land purchase for new home development in the Ken-Caryl Ranch Plains. The land is currently zoned for residential use and includes the following locations:

- Parcel A: North of Ken Caryl Ave. and east of C-470 (also called the North Bowl)
- Parcel B: Southwest corner of Chatfield/Simms and Ken Caryl Ave. (north of the Sunset Ridge community)
- Parcel C: North of RTD Park'n Ride

These properties are privately owned and will be within the boundaries of the Master Association. The homeowners will pay dues like the other homes on Ken-Caryl Ranch. However, the homes are not currently within the boundaries of the Ken-Caryl Ranch Metropolitan District. They are in the Plains Metropolitan District. There are no additional details at this time, but Master Association staff will work with the developer on future announcements. A Season of Change

With more time spent at home these days, and warmer weather on the way, comes the need to engage in a little spring cleaning. During the winter, the Master Association proactively inspects neighborhoods once per month. Starting in May and through September, those inspections increase to twice per month to accommodate landscaping inspections. We'll be looking for weeds, lawns that need to be mowed or watered, overgrown shrubs and trees, rock beds and garden wall maintenance, and overall general yard maintenance.

As the Parks Department, coming off of some major snow removal work (and not quite out of those woods just yet), is hard at work getting ready for the spring and summer seasons, here are a few things homeowners can do now in preparation of spring:

- Check your equipment for any needed repairs or maintenance. Sharpen lawnmower blades, fill up tires, check oil and belts in motors, etc. Do your hand tools need sharpening, cleaning or repair? Is the hose on your pressure washer cracking? Where do you get a new hose?
- Clean out planting and rock beds, pull

out old growth and fallen leaves to make room for new plants and for perennials to come back. Maintain weeds and grass in rock beds as they come up, so they don't get out of hand.

- Have your lawn aerated. This will help the air exchange in the soil, allow for better water absorption and strengthen the roots. Check with a professional to see how this process can be a benefit to your yard. Ask your neighbor who they use, or check out the Contractor Reference Database on our website at www.kencarylranch.org.
- Around the end of the month is a good time to start thinking about fertilizer products and what works best for your property.
- As the nighttime temps warm up closer to the end of spring, check your irrigation systems. If you have some damage to your system, plan for an alternative water source to keep your yard healthy until it gets fixed.
- Don't forget your safety gear! Gloves, goggles, hats, sunscreen and whatever you need to have a safe and enjoyable experience in your yard this season! It's still cold, and some areas are still



Open Space Weed Management

Spring is here, and along with warmer temperatures and longer days, weeds are starting to appear in lawns, parks and open space areas. As part of an integrated management approach, herbicide applications and mowing are used to combat weed infestations in our open space. This year's herbicide applications will be conducted from approximately March to July depending on weather and growing conditions. Mowing operations are usually performed in late summer to prevent seed production. Some follow-up spraying in fall may occur if there is re-growth after the summer mowing operations.



Bare ground areas like picnic pads, hard surface trails and kiosk pads are treated first with a pre-emergent herbicide. Applications can be conducted before weeds emerge and these herbicides prevent weeds from germinating in the area throughout the growing season.

The next weeds managed are the biennial weed species like Musk thistle and Mullein. Mullein and Musk thistle are on the Colorado noxious weed list, which mandates that landowners make attempts to control and stop the spread of these weed species. The first year and early spring growth forms for these weeds is a rosette of basal leaves lying close to the ground. At this stage, they are most vulnerable to chemical application because of their increased uptake of water and nutrients. Even though Mullein and Musk thistle can be effectively treated all the way up to the budding stages, we have found that spring and fall spraying in the rosette stage is most effective.

As spring turns into summer, management efforts shift to deeply-rooted perennial weeds like Canada thistle. Spraying Canada thistle and other deeply rooted perennials is more effective when the plants have bolted and grown to approximately 10" in height. At this point, they are still transporting nutrients to the root system, which will allow for more herbicide uptake. Mowing is also an effective way to make the perennials use more energy as they attempt to recover from the mowing. Mowed perennials are also more susceptible to fall herbicide applications.

The weeds being managed this season are very aggressive invaders, which have the potential to take over native plant communities. Priority was given to areas where infestations pose the worst threat to native plant communities and where they are bordering home lots. A contract herbicide applicator and the in-house open space crew will be performing the herbicide applications.

Our Community



Businesses also use census data to decide where to construct factories, offices and stores, which is an essential economy boost that creates jobs.





What Determines Wildfire Behavior?

All of our homes within Ken-Caryl are within the Wildland Urban Interface (WUI), an area of increasing risk for wildfire. Multiple factors interact to determine the behavior of wildland fires. Fire behavior refers to the intensity at which a fire burns, the rate of spread and how it moves. General descriptions of wildfire behavior focus on where the fire occurs in the vegetation: underground, on the surface, and in tree crowns.

Ground fires are fires that burn below the surface. With the rocky soils of Ken-Caryl, ground fires are not common. During surface fires, fuels at or near ground level, such as grass, shrubs, and/or fallen leaves and branches, carry the fire. Crown fires burn through the tops of trees. In general, the relative intensity (amount of heat released) of the different types of wildfire increases from ground to surface to crown fires. Firebrands, burning embers, which may be carried for a mile or more, may originate from surface fires or crown fires. Structural fires, or burning homes or buildings, are another type of fire that can produce firebrands.

Three factors interact to determine fire behavior in wildland fires: fuels, weather and topography.

Fuels: The primary fuels in wildland fires are living and dead vegetation. During extended periods of warm and dry conditions, all plants will burn if exposed to enough heat. However, plants differ in how readily they ignite and how hot or long they burn. Flammability depends on arrangements of decks and landscaping, plant size, arrangement of branches and leaves, and chemical properties of branches and bark. The Gambel oak brush common to the Front Range of Colorado and the Western United States burns hot and fast, even when green.

Weather: Precipitation, humidity, wind and temperature are important weather variables that influence fire behavior. Precipitation and humidity, which are influenced by air temperature, directly influence the flammability of all fuels by affecting the moisture content of living and dead leaves, branches, and grasses. Plant materials dry out quicker and ignite easier during hot, dry weather. Windy conditions as are seen during Red Flag Warnings on hot, dry and windy days, increase the rate of spread of fires and may increase fire intensity.

Topography: Topography significantly affects fire behavior. Fires move faster uphill than downhill. Slope orientation also influences fire behavior. Forests on southern or southwestern slopes generally have lower humidity and higher temperatures than those on north or northeast slopes because of the path of the sun. Look to the

foothills west of Ken-Caryl Valley and notice the density of fuels on the north-facing slopes. Consequently, fire hazard is often higher on south and southwest facing hills.

Of the three factors affecting fire behavior, fuels are the easiest to manage by homeowners to lower fire hazard.

Strategies to Reduce the Risk of High **Intensity Fires**

Homeowners in high fire hazard areas can reduce the risk of high intensity fires affecting their property. An important concept for homeowners living in hazardous areas is that of defensible space. Defensible space is defined as an area of modified vegetation between wildland fuels and homes that allows firefighters to protect the home or, in the absence of firefighters, allows the home to better survive on its own. The most extensive modification of vegetation should occur within an area of at least 30 feet around the house. Beyond this area, additional modification of landscaping creates a larger buffer from an approaching wildfire and further decreases the risk of damage, as well as giving your family and neighbors more time to evacuate during an approaching wind-driven wildfire.

Create and maintain a defensible space by removing the lower branches up to 10 feet from the ground on large trees, separating beds of landscape plants, and removing flammable vegetation from within 30 feet from your house. Homeowners living on a steep slope or hillside should maintain a larger primary zone of defensible space on the area below the home.

Landscape your yard with Firewise plants with the following characteristics: slow growth with little accumulation of dead vegetation, high moisture content and low concentrations of oils or other flammable chemicals in the leaves and branches (e.g. succulent plants), and an open and loose branching pattern. If natural areas exist on your lot, you can reduce the intensity of an approaching fire by:

(1) removing highly flammable shrubs and trees;

(2) reducing overall tree density by removing small trees (called thinning); and (3) reducing the continuity of ladder fuels.

Now is the Time for Mitigation

When wildfires occur near homes, homeowners often feel powerless to protect their property. An approaching fire may seem unpredictable and difficult for trained firefighters to control. However, with an understanding of the concepts of fire behavior outlined in this paper, you can anticipate the intensity and movement of a fire by considering several key conditions: fuel structure, local weather, and topography. Furthermore, by altering the conditions around your house, such as decks and outdoor furniture, you can influence the movement and intensity of fires, and consequently, improve the survivability of your home.





7 Life at Ken-Caryl April 1, 2020

As the dawn broke at the end of last
week, clouds loomed threatening snow and
cold presenting a reflection of the impact
of COVID-19 and its impending threat. Yet,
at the Action Center, there is an emanating
glow from staff and volunteers as they work
to continue meeting the critical needs of
our community. Abuzz with movement, the
Action Center's team has been hard at work
organizing, stocking, packing, and loading
meal kits into the vehicles of those who
need it most through the organization's
drive-thru distribution.

While the past week has presented challenges and hurdles, the staff and volunteer team of the Action Center hasn't let this get them down. They continue to rally for their community in a significant way. Starting many weeks ago, the organization began planning and created an impressive program that protects its participants, staff and volunteers and ensures that there is no break in the services they can currently provide. With plenty of social distancing, and sanitizing protocols in place, every day, 15-20 volunteers appear for a morning and afternoon shift, determined to serve the most vulnerable in our community. Supported by 10 Action Center staff, this resolute group, manning their stations, greets cars as they pull up to collect meal kits, which are then rolled out on carts and loaded into their vehicles.

Each vehicle has a story to tell, and while working on the front lines I had the privilege of asking Action Center participants how they were doing. One woman drove up with the usual children's clutter in the backseat. I asked how her kids were doing and how her job was going. To which she replied "Well, they (children) think that the break is pretty good – thankfully, I am able to work from home. However, my husband lost his job yesterday, so we will see. Thank you for helping us out!"

In another interaction, I greeted an elderly gentleman who walked up slowly, in the rain to the food tent. While he waited patiently, he was quite talkative and told me about his 17 back surgeries and planned hip replacement surgery he is to have at the VA this week. He is worried about having enough food to get him through his recovery period. Thankfully, the Action Center is able to provide meal kits to this veteran and many others like him on a bi-weekly basis as we all weather the storm of COVID-19.

Another gentleman believes in hope in the midst of troubles, he said to me: "I've lost jobs before, but never two within one day with no notice. But I know how to find work and I'll get another job."

For each of these stories, there are many more. Each is a reminder of how the Action Center serves its community in the midst of any circumstance.

1.) Why have you declared your candidacy for the Metropolitan District Board of Directors? Please explain why you chose to volunteer to serve on this Board.

My involvement in my homeowners' association in Florida followed that same path: encouraging civil conversation to problem-solve zoning and covenant issues.

My experiences with issues relating to the Ken-Caryl Metropolitan District have also centered on respectful problem solving. The comprehensive, independent 2017 Ken-Caryl Ranch Community Residents Survey reveals that most of the 13,000 residents in Ken-Caryl value the same core principle: Protect our services and amenities – they are why we chose to live here – and do so while being responsible stewards of our tax and fee dollars (Metropolitan District) and HOA dues (Master Association).

With all due respect to those who passionately advocate for single agendas – and not to minimize their often-important passions – I am not a single-issue candidate for this board, which is why I believe I would be a good addition to the board. 2.) What skills and/or qualifications would you bring as an asset(s) to the KCRMD Board of Directors?


