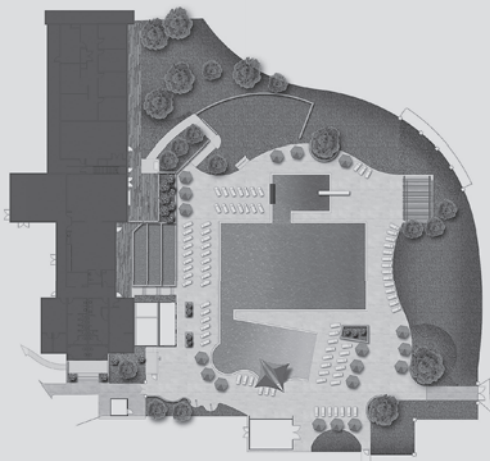

Master Association

On March 19, the Ken-Caryl Ranch Master Association Board held a regular business meeting and discussed the following items:

- Resident Rilla Reinsma questioned why the Master Association does not do seasonal trail closures for raptor nesting season. Open Space Manager Sean Warren addressed her concerns and said Master Association trails are outside the .5-mile buffer zone that is required by Colorado Parks and Wildlife. The Board requested staff contact Jefferson County Open Space and Highlands Ranch to find out what trails are being closed, during what time periods, and why they are being closed if more than .5-mile outside the trail. Staff will communicate the answer to the Board and community.
- The Board discussed the hiring committee to identify a new Executive Director for the Master Association. The next step will be for the committee to meet regarding the hiring process. Resident Bruce Heise addressed the Board and encouraged them to hire Victoria DeSair and not go through the hiring process. Resident Dan Mullins asked if the committee needs to meet in open forum. Because the hiring process is a personnel matter, the hiring committee meetings can be done in Executive Session.
- The Board discussed whether to have an Equestrian Center Task Force since there were only two new applicants. The Board tabled the discussion until the April business meeting when Erlinda Stafford and Chris Pacetti are present.
- A motion passed appointing Master Association Board officers and committee liaisons for 2019. The 2019 officers are as follows:
 - o President: Chris Figge
 - o Vice President: Dave Seagraves
 - o Treasurer: Erlinda Stafford
 - o Secretary: Andy Lydens
 - o Director-at-Large: Scotty Martin
 - o Vice President: Chris Pacetti
 - o Assistant Secretary: Victoria DeSair
- The 2019 Board committee liaison appointments are as follows:
 - o Chris Figge: Architectural and Covenant
 - o Scotty Martin: Community Planning and Metropolitan District Board
 - o Erlinda Stafford: Equestrian Center Task Force
 - o Dave Seagraves: Office Park and Historical Society
 - o Andy Lydens: Open Space Committee
- A motion passed adopting Resolution 19-01 indemnifying former Board member Seth Murphy.
- A motion passed authorizing an additional expenditure of \$11,873 for pilot kiosk project. Funding source 2018 Special Project Fund.
- A motion passed adopting the amended Volunteer Trail Coordinator Program Description.
- A motion passed adopting Resolution 19-02 removing Seth Murphy and adding Board President Chris Figge to all Master Association bank accounts as an authorized signer.
- A motion passed approving Exhibit D to the First Amendment to the Reorganization Agreement. Exhibit D shows a breakdown of how the 2014 bond money was spent and the useful life of the improvements that were made on Master Association property.
- A motion passed approving the Second Amendment to the Reorganization Agreement. The amendment transfers financial responsibility for Master Association-owned water taps from the Metropolitan District to the Master Association.

- A motion passed authorizing the Board President to enter into an open book bid process agreement with A.D. Miller to replace the Ranch House swimming pool.
- A motion passed authorizing the Scope of Work for 2019 Trail Maintenance with Singletrack Trails. Resident Jack Sawatzki questioned why three bids weren't sought for the project. Staff explained that there are only two companies in the area that do this type of work. The other company previously did work for the Master Association that was unsatisfactory.
- The Board previously asked for clarification from the Open Space Committee on the naming of Docmann Trail. The Committee suggested the whole trail be named Docmann, and the small spur off Docmann would be named Overlook.
- Staff is currently reviewing the Collections Policy with the attorney. A revised policy will be presented to the Board at a future meeting.
- In February, the Board approved going to court for an injunction to force Account #31750 to fix ongoing covenant violations. In response, the resident reached out to the Association's attorney and came to an agreement on a timeline to fix the problems.
- Staff reported on Ranch House Pool design feedback from the open houses and the current online survey. So far, the response has been positive, and specific feedback will be considered by the Boards and architect.
- Staff attended the Community Associations Institute spring conference.
- Resident Jim Fodor wants pool design aesthetics to be weighed in the

decision-making process.

- Resident Jack Sawatzki questioned the construction of the steps on Massey Draw Trail. Volunteers fixed the issue over the winter.

Metropolitan District

On March 26, the Ken-Caryl Ranch Metropolitan District Board held a regular business meeting and discussed the following items:

- The Board celebrated the 35-year service anniversary of Parks Director Pat Malloy.
- The Board discussed the preliminary feedback from the Ranch House Pool Renovation open houses and online survey. So far, the responses have been largely positive and provided helpful constructive feedback.
- Staff presented a possible Personal Information Policy for the Board to review. Recent changes in the law require the Board to adopt a new policy for securing any personal information retained for employee files or patron registrations.
- Staff gave an update on the Americans with Disabilities Act (ADA) Transition Plan. Several improvements were made to facilities as part of the bond projects, and many more ADA improvements are planned with the Ranch House Pool Renovation.
- Staff gave an update on the S. Valley Road / Club Drive intersection. Staff is working with Jefferson County to explore potential safety improvements to the intersection.
- A motion passed to accept the proposals from the Colorado Natural Heritage Program and ERO Resources Corp to conduct biological surveys on the South Hogback. The surveys will include rare plant and animal habitats and archeological and historical studies. The Board did not approve the bat and owl surveys at this time.
- A motion passed to approve Exhibit D to the First Amendment to the Reorganization Agreement outlining Master Association property improvements.
- A motion passed to adopt the Second Amendment to the Reorganization Agreement outlining the water tap financial responsibility.
- A motion passed to approve the 2019 Ken-Caryl Community Garden Gardener Agreement.

Seasons Change

As we enter into another beautiful season, the time has come to tidy up and do some spring cleaning. We

are seeing promises of green sprouting up around the ranch, and our lush lawns and glorious gardens are just around the corner!

During the winter, the Master Association proactively inspects neighborhoods once per month. Starting in May and through September those inspections increase to twice per month to accommodate landscaping inspections. We'll be looking for weeds, lawns that need to be mowed or watered, overgrown shrubs and trees, rock beds and garden wall maintenance, and overall general yard maintenance.

The Parks Department, coming off of some major snow removal work (and not quite out of those woods just yet), are hard at work getting ready for the spring and summer seasons. Pat Malloy, Parks Department Director for Ken-Caryl Ranch Metropolitan District, has helped care for Ken-Caryl Ranch for 35 years (Congratulations!)! Pat and his team have a passion for their work and do a fantastic job maintaining the properties. Did you see the greenbelts and flower gardens last year? Mr. Malloy was kind enough to share a few moments of his time with me to talk about what he and his team are doing to prepare for the upcoming (busy) seasons and to share some tips on how residents can start getting ready now, too.

The transition between seasons can be tricky, so some tasks will have to wait for warmer weather. It never hurts to consult a professional, but here are a few things homeowners can do now to prepare:

- Check your equipment for any needed repairs or maintenance. Sharpen lawnmower blades, fill up tires, check oil and belts in motors, etc. Do your hand tools need sharpening, cleaning, or repair? Is the hose on your pressure washer cracking? Where does one get a new hose?
- Clean out planting and rock beds, pull out old growth and fallen leaves to make room for new plants and for perennials to come back. Maintain weeds and grass in rock beds as they come up, so they don't get out of hand.
- Have your lawn aerated. This will help the air exchange in the soil, allow for better water absorption, and strengthen the roots. Check with a professional to see how this process can be a benefit to your yard. Ask your neighbor who they use or check out the Contractor Reference Database on our website at www.ken-carylranh.org.
- Around the end of the month is a good time to start thinking about fertilizer products and what works best for your property.
- As the nighttime temps warm up closer to the end of spring, check your irrigation systems. If you have some damage to your system, plan for an alternative water source to keep your yard healthy until it gets fixed.
- Don't forget your safety gear! Gloves, goggles, hats, sunscreen, and whatever you need to have a safe and enjoyable experience in your yard this season!

It's still cold, and some areas are still dealing with ice and snow on their properties. We all know the rule not to plant before Mother's Day, but there is still plenty we can do to get ahead of the work so we can spend more time enjoying our outdoor spaces.

Staff Highlight: Peter Marozas, Park Ranger

My name is Peter Marozas, and I am one of the Ken-Caryl Ranch Park Rangers who works for the Master Association's Open Space Department.

In August 2019, I will be celebrating my 7th year working for the Ken-Caryl Ranch Master Association. I was hired back in 2012 and started my career here as the Trails Specialist. After two years working on trails, I transitioned into a new position that focused on General Maintenance.

Prior to working at Ken-Caryl Ranch, I worked as a wildland firefighter for the Bureau of Land Management in Phoenix, Arizona. After making my move to Colorado in 2006, I worked two years at Chatfield State Park for the Aquatic Nuisance Species and Land Patrol Program. There I was responsible for watercraft inspection and decontamination for zebra and quagga mussels and also responsible for night patrols of the park. After that I went and worked two years for Colorado Parks and Wildlife, continuing my career and experience with the Aquatic Nuisance Species Program during the fall/winter. I was involved in sampling and monitoring of a vast majority of Colorado lakes and reservoirs and watercraft inspection and decontamination

quality control. When summer of 2010 rolled around I began working for Jefferson County Open Space with their trails program. I worked several seasons there honing my skills working with heavy equipment and building all types of soft surface, crusher fine, and ADA accessible trails.

Here is a list of my primary duties throughout my work week:

- Service and maintain dog waste stations and bearproof trash cans.
- Responsible for roadside mowing and trailside buffer strips.
- Responsible for sign design, ordering, and installation.
- Fence installation and repair.
- Responsible for repair maintenance of two-track, crusher fine, and hard-surface trails.
- Assist Volunteer Trail Club with tools, supplies, and support.
- Recruit, hire, train, and supervise Seasonal Maintenance Technicians.
- Assist with set-up and tear down of special events.
- Inspect and repair open space structures.
- Assist with wildlife calls and education.
- Graffiti and vandalism cleaning and restoration.
- Responsible for snow removal at Dakota Lodge and Equestrian Center.
- Assist with various shared duties as outlined in previous Ranger articles.

The day-to-day duties of my job can change in a minute. Each day I encounter new challenges, but that is what makes working at Ken-Caryl Ranch a unique, yet very rewarding job.

Twice a year the Jefferson County Sheriff's Office joins law enforcement agencies nationwide to remove potentially dangerous controlled substances from our nation's medicine cabinets. The Drug Take-Back Day on Saturday, April 27 from 10 a.m. - 2 p.m. provides an opportunity for the public to surrender expired, unwanted, or unused pharmaceutical controlled substances and other medications for destruction. These drugs are a potential source of supply for illegal use and an unacceptable risk to public health and safety.

- The program is anonymous.
 - Prescription and over-the-counter solid dosage medications (tablets and capsules) are accepted.
 - Intravenous solutions, injectables, needles, and oxygen containers will not be accepted.
 - Illicit substances such as marijuana or methamphetamine are not a part of this initiative.
 - The prescriptions should be removed from the original containers and placed in a plastic bag prior to drop off.

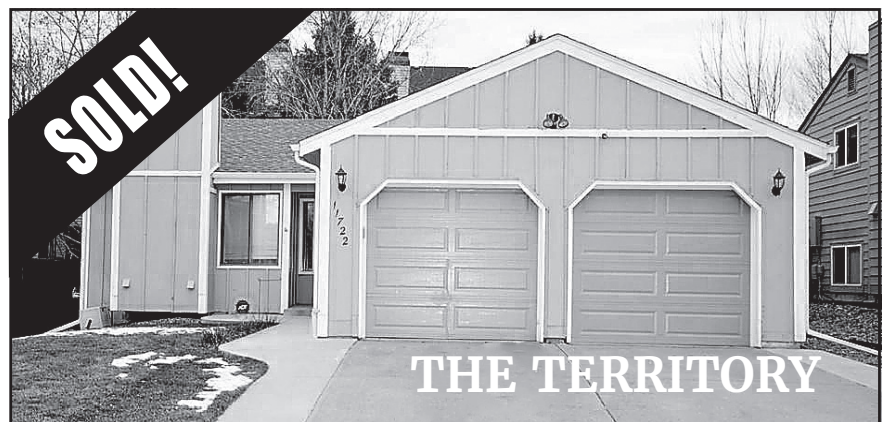

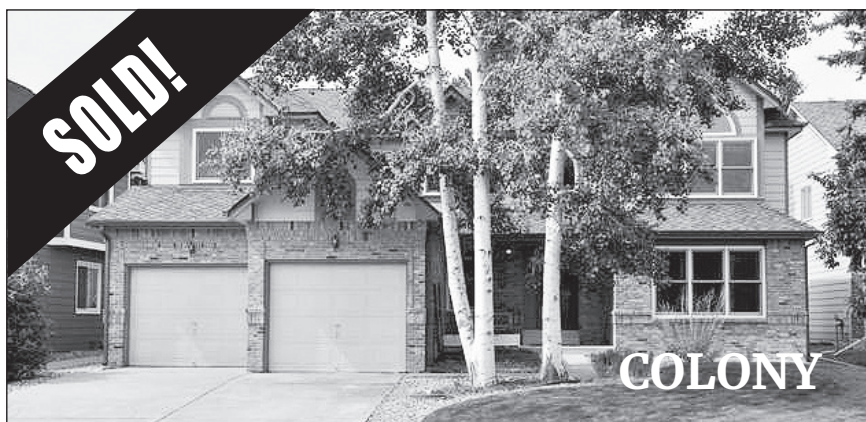

Preparing your Pets for Evacuation in Wildfire

Most families own pets, and our animals rapidly become members of the family, with deep emotional attachments. When battling a wildfire, firefighters will do what they can, but we must prepare for the care of our pets in wildfire.

Be Prepared

Just as wildfire preparedness for you and your family begins with the home, also consider all the places where your pets live. Structures such as dog kennels should be maintained and prepared for wildfire just as your home and its surrounding landscape. All structures and their surroundings should be included in your defensible space or have defensible space of their own.

Evacuation Planning

A good evacuation plan should include your pets. Preparing animals for a wildfire evacuation requires an extra level of planning, preparedness, and practice. Animals are very sensitive and will respond to a fire that is anywhere within their sensory range. Normal reactions range from nervousness to panic and aggressive escape attempts.

Identify Evacuation Routes

Fires can move quickly, so it is best to identify at least two evacuation routes. If towing trailers, drive all routes to ensure compatibility with the road's width and grade before a disaster strikes - a stuck trailer could prevent others from using the same way out.

Know Where to Take Your Animals

Local authorities, such as Jefferson County Animal Control, will identify shelters for small and large animals. Check with your veterinarian for additional locations to shelter animals in an emergency.

Share Your Plan

Family and neighbors should have a copy of your plan in the event you are not home when a wildfire evacuation is ordered for your area. Make sure everyone has all contact numbers (cell phone, work, home, etc.).

Prepare Emergency Kits for Pets

When building the kit, choose a container that is easily loaded into vehicles. Keep your emergency kits in an easily accessible, dry location where temperatures do not get hot or below freezing. Consider leaving your kit in the garage where family and neighbors can quickly load it with your pets for safe evacuation. To begin, gather some handy tools:

- Large bin or tote with lid (preferably waterproof)

- Clear, waterproof, sealable plastic bags
 - A permanent marker for labeling contents
 - Pen/pencil and notepad for documenting special details and needs
- Your kit should include:

Identification. All pets should be wearing properly fitted collars with personal identification, license, and rabies registration tags. Include a relative's phone number in case you and your pet get separated.

Copies of important papers and phone numbers. Cell phones and Internet access could be temporarily out of service, so include a paper list of all important phone numbers (veterinarian, animal shelter/boarding facility, neighbors/friends). Also include:

- Copies of current vaccination/medical records and health certificates, proof of ownership, pet health insurance policies, breed registration papers, brand inspection, photos of brands, and current photos of each animal showing unique markings or embedded chips.
- A list of all current medicines and doses.
- Written permission to care for your animals and instructions for accessing

animal emergency kit(s).

Food and water. Store a three to seven day supply of food and water for each animal. Include non-spill bowls, buckets, can openers and spoons.

First-aid kit. Include cotton bandage rolls and tape, scissors, antibiotic ointment, medical-type gloves, isopropyl alcohol, and saline solution. If possible, keep an extra supply of medications your animals take on a regular basis. Ensure each is labeled with the animal's name and description. Include a list of each animal's current physical disabilities or illnesses, emotional or behavioral problems and how to deal with them, special feeding schedule/requirements, dietary restrictions and/or allergies.

Waste disposal. Pack a small cat litter box, scoop and litter, plastic bags for waste disposal, newspapers, paper towels, disinfectants and hand sanitizer.

Miscellaneous items. Having personal items such as blankets, toys and treats can help calm your animals. Include:

- Non-nylon leads, ropes and halters (nylon melts)
- Leather gloves
- Muzzle(s) (if needed)



- Grooming supplies
- Portable radio
- Batteries
- Flashlights

In the Event of a Wildfire

Don't wait for an evacuation order. Preparing your pets and animals may take time. Leaving early is the best way to ensure human and animal safety.

Dress for safety. Put on socks, closed-toed leather shoes or boots, long pants, and a long-sleeved shirt. Leather gloves, a bandanna, and a hat can be handy.

Ready your vehicles. Hitch up trailers and park all vehicles facing the direction of

escape. Put emergency kits into vehicles and consider leaving the keys in the ignition as you prepare to evacuate.

Ready your animals. At the earliest signs of a wildfire, your pets should be brought inside and/or kenneled. Cover kennels and cages with a light cloth to minimize fear.

Contact the neighbors. Check with neighbors to see if they need assistance and tell them when you'll be leaving and where you'll go.

Leaving Your Animals

During a wildfire, local animal rescue organizations work with law enforcement and fire departments to evacuate as many animals as they can, but sometimes homeowners have to leave their animals behind. If you cannot evacuate your pets, bring them indoors.

- NEVER leave pets chained or kenneled outdoors; the smoke and heat from flying embers are not only scary but dangerous to your pet's health.
- Put pets in an easily cleaned room that has adequate ventilation but NO windows (utility room, garage, or bathroom).
- Do not restrain pets.
- Leave dry food and fresh water in non-spill containers. If possible, let a faucet drip water into a large container or partially fill a bathtub with water.
- Put a sign on your house on or near entrances informing responders that there are animals inside.

Caring for Your Animals After Wildfire

Once you are given the "all clear," there are things you need to know, and do, to make your return safe. Dress for safety and do an initial inspection of your property. Once you have secured the area, locate your animals and immediately provide clean water for your pets.

Check animals for injuries. Animals are often injured or killed by running into fences and barriers while fleeing. Burns, lung inflammation, and edema from smoke inhalation are common health problems. Have animals inspected by your veterinarian ASAP. Monitor animals for several weeks afterwards.

Report missing animals. Provide local authorities with the last known location, identification, and disposition of any missing animals, especially if they are aggressive.

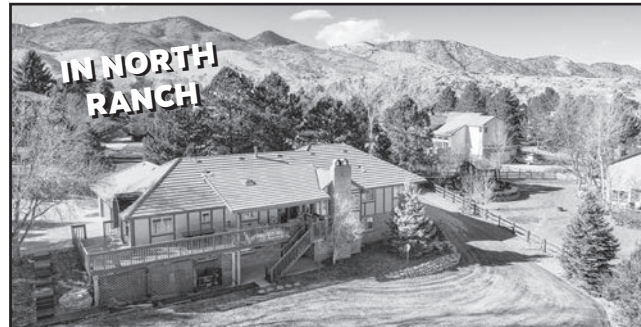

Dear Editor:

The Metropolitan District Board and Staff recently received feedback regarding the MD's budget, the cost of the Ranch House Pool project, and the Resident Pool Access Fee. MD tax revenue has declined in recent years while expenses have increased, creating a strain on the MD's financial situation. Because of this, the MD Board voted to place a mill levy initiative on the ballot in 2018. The mill levy was voted down by residents, forcing the MD Board to find other ways to cut expenses and increase revenue. Such changes included increasing youth program fees, charging users for credit card processing fees, cutting two positions in the Parks Department, and many more.

The MD Board also discussed charging residents a daily-use fee for pool access. After hearing from the community, the MD Board decided not to charge daily-use fees but asked staff and the community to find a solution to help offset some of the cost of operating the pools. The pools cost the MD more than \$250,000 per year to operate. Staff solicited feedback via email and through various community meetings. Based on this feedback, the MD Board implemented a pool access pass fee. This fee only needs to be paid once per year and gives you unlimited access to the pools all summer. This suggestion was well received in community meetings.

Regarding the Ranch House Pool renovation, the cost of the project is \$3.6 million. Lawsuit settlement money of \$2.25 million is coming from the Plains Metropolitan District. The lawsuit funds must be used for pools, tennis courts, or ballfields. The money can't be used to offset

operational expenses. The remaining \$1.35 million is coming from MA reserves and operations. Some previous improvements that were done at the Community Center splash pad were funded with grant money, which can't be used for operations.

While the budgets and operations of the MD and MA can be confusing, we encourage

everyone to reach out if you have questions. Budget documents and meeting minutes are available on the website. Board decisions are made at public meetings, and residents are welcome.

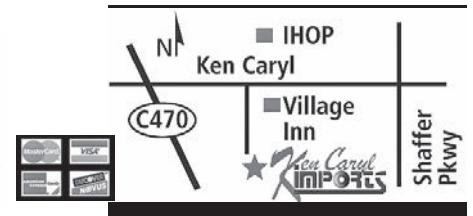
