Reminder to Bundle Branches

Our trash provider, Waste Connections, is reporting issues with tree branches left out for pickup. The driver is trying to pick up what he can, but there are more branches out than usual. Branches must be tied and bundled in lengths not to exceed four feet and no greater than one foot in diameter and weigh less than 40 pounds. If they are not bundled or are too large, Waste Connections will not pick them up.

Financial State of the District

By Co-Interim District Manager Jeff Leniger

I am so grateful to the District Board for their confidence in Pat Malloy and myself during our District Manager transition, and for the District staff taking on so many different and additional responsibilities. We have dealt with a lot of challenges this year, but we are still having fun and taking pride in the incredible work we do for the Ken-Caryl community.

We have reason to be very optimistic about the financial outlook for the District heading into the summer. The financial picture has changed dramatically

since the ballot issue in November 2018; here are the key financial developments:

- The initial projections the District received during the mill levy campaign estimated a Residential Assessment Rate ("RAR") of 6.11 for property tax years starting June 1, 2019. Colorado Senate Bill SB19-255 passed on April 30, 2019, setting the next RAR at 7.15. Bottom line, this improves District revenue projections by approximately \$350,000 per year. This will balance the District budget and help our staff maintain the same level of service excellence for the Ken-Caryl community.
- Our external audit will be issued with an unmodified (clean) opinion in June 2019 and for the second consecutive year, the District finished the year with improved operating cash reserves.
- District staff implemented changes that will help us improve cash flow and contain costs at the margin of our operations.
- We are improving systems and processes for everything from records retention to data analytics by modernizing our information technology infrastructure. This creates a positive feedback loop where staff time is used more efficiently, staff have more insight into financial activity, and the District builds more transparent and financially successful budgets.
- The District will pay off its bonds in 2024 and will be incorporating a capital asset replacement schedule in future budgets.

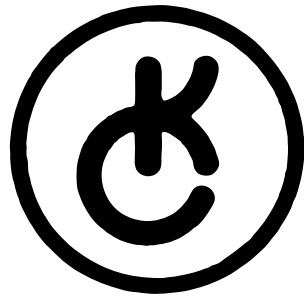

Joint Study Session

- Chris Pacetti read a letter from Doug and Nancy Everhart expressing their concerns about the community's finances and increased fitness center costs.

personal benefit is unfair to other property owners.

Planting in Open Space

Includes trees, shrubs, non-native vegetation, or any other non-approved plantings. Planting non-native species can compete with native species. Problems in the past have included trees dying due to lack of water or a very dry season, adding to the maintenance workload by removing from open space.

Communicating With Your Contractor

Another problem that I experience often is the lack of communication between a homeowner and their contractor. A homeowner who borders open space can submit a plan, which in turn will alert the ranger staff. Staff will come out to the property and mark the boundary line next to open space. This helps the owner and contractor reduce any potential landscape rule violations. Twice this season an owner had to have the contractor return to remove dirt dumped in the open space from a project in their yard.

Rules Violations

The Ken-Caryl Ranch Master Association Board of Directors adopted a strict enforcement policy regarding rules violations. The enforcement procedure (except dogs off leash) will be applied as follows:

- Rangers will write the member a Contact Notice for any rules violation and direct the owner to mitigate the violation. Any subsequent rules violation in a 36-month period may result in a Notice of Hearing to appear before the Master Association Board of Directors.

Pursuant to Section 3.08 of the Amended and Restated Master Declaration of Covenants, Conditions and Restrictions of Ken-Caryl Ranch, the Board of Directors of the Ken-Caryl Ranch Master Association can invoke one or more of the following remedies after giving the owner Notice and Hearing:

- 1) Impose a special charge (fine) upon such owner of fifty (\$50) for each violation. If the fine remains unpaid for a period of ten days or more, it may become a continuing lien against the property.
- 2) Suspend the right of such owner and his family, guests, licensees, lessees, and invitees to use Association property for a period of not more than thirty (30) days for each violation.
- 3) Cause the violation to be cured and charge the cost to such owner. A continuing lien may be placed against the property for the cost to cure.
- 4) Seek injunctive relief from a court of competent jurisdiction to enjoin the violation.

Landscape Projects and Rule Violations

The month of June is a good time to work on landscaping projects, especially after the moisture received this spring. Adding plants, mulch, and other material will help add value to your property and give you a sense of satisfaction that your home is inviting to visitors. While you are completing your projects on your property, remember to respect your open space areas. The following are examples of rules violations and how they impact the resources contained in open space.

Dumping

Includes grass clippings, branches, other yard waste, dog feces, and construction debris. Harm to the open space includes yard waste containing seeds of non-native plants that can germinate and crowd out native and other desirable plants in the open space. Dump piles can provide habitat for rodents and snakes that you may not want living close to your house. The open space is not a public dumping area but is shared by everyone to enjoy!

Driving in Open Space

Includes contractors using open space to access owner's property, transportation of materials, ATVs, or any other unauthorized vehicles in open space. Harm to the open space includes destruction of property, bare spots that are susceptible to weed invasions (expensive to fight noxious weeds), unsightly scars left in the open space, and erosion of bare soil.

Excessive Mowing

Includes mowing beyond the allowed 10-foot wide swath where private property meets open space. Harm to the open space includes: excessive mowing prevents seed development of native plants not allowing them to reseed, some native plants can be killed by excessive mowing, variations in excessive mowing creates an unsightly mosaic of the private property/open space boundaries.

Structures

Prohibited structures include retaining walls, pathways, trails, extension of private landscaping, birdfeeders, play equipment (swing sets, trampolines, etc.), invisible dog fences, other fences, or any other structures. The use of open space for

Parking for Manor House Trail

We wanted to remind residents about parking at the Manor House now that there is a gate at the entrance. The gate will automatically open when a car approaches between the hours of 6 a.m. and 10 p.m. daily. Residents can park in the parking lot during those hours unless there is an event, in which case a sign will be posted. When the lot is closed, residents who wish to access Manor House Trail are asked to park along Ken Caryl Road/North Ranch Road (see map). You are never permitted to park on the shoulder of Manor House Road. Also, please be respectful of the neighbors who live near the Manor House by not turning around in their driveways.

Spring Trail Work

The Ken-Caryl Ranch Volunteer Trail Coordinators, Dan Mullins and Jeff Lyslo, have been working this spring on several tasks associated with the open space trails. Our role, as assigned by the Master Association Board, is to be responsible for all trail maintenance, coordination of any new construction, as well as project management and planning of any related activities. So far this spring our primary activities have included:

1. Updating the trail maintenance plan to identify projects for annual trail maintenance. The projects were reviewed and approved by the Open Space Committee and MA Board. We separated projects into those that would be completed by a contractor and those to be completed by volunteers.

2. Directing and reviewing the work of the contractor performing maintenance activities. As the season progresses, we will also review the work of volunteers performing trail maintenance activities.

3. Working with volunteers to plan for vegetation maintenance along our trails, to control growth of vegetation into the trails. The primary growing season for our trails is the months of June and July, and volunteer crews will be out soon to begin work. 4. Reviewing possible alternate alignments of an eroded social trail that connects the end of Mountain Cedar Lane to Valley Parkway, as requested by the Open Space Committee and KCR Staff. Staff was simultaneously reviewing options for closing the social trail. We met Philip Varley (a nearby homeowner) on site to understand the historic use of the

trail and allowed him to participate in our field activities of determining possible alternative alignments.

We have received several questions about the trail maintenance work, many of which are addressed below.

All of the work performed was done to improve the durability and sustainability of the trails. The tread maintenance is most often performed to correct identified soil erosion and deposition problems. When a trail erodes, it is not sustainable and potentially can have negative impacts on open space natural resources and user experience of the trail. Erosion on trails is evident when we observe a cup-shaped tread, a substantial amount of loose rock on the trail, or drainage dips that have filled in over the past few years.

The erosion issues are more frequently observed on high-use trails as well as legacy trails. Legacy trails are our older trails that often have a steeper grade and didn't incorporate modern trail sustainable practices. To combat trail erosion issues, the most common solution is to install drainage features. The drainage feature most frequently used is called a rolling grade dip, also known as a roller or a drainage dip, and are the best-practice solution to trail erosion well documented in U.S. Forest Service guidelines and other publications. These drainage features, which are commonly seen around other local trail systems such as Jeffco Open Space, serve to capture any water that is on the trail surface and direct it away from the trail.

The spacing of the drainages is dictated by the trail grade and by the type of soil. Trails that have a steeper slope and/or have softer soils require closer drainage spacing. When rolling grade dips are constructed or reconstructed, we prefer to construct larger features, as the cost difference between making a small drainage dip and

a large drainage dip is negligible but a larger feature will last much longer, which minimizes the frequency of maintenance, reduces costs over time, and minimizes the visual impact over time (due to less frequent disturbance). Most of the drainage work performed this year was on existing features that had filled in or were no longer effective; very few new drainage features were constructed.

The rolling grade dips are not an attempt to make a mountain bike course, in fact many bicyclists don't like these features, but they are necessary to maintain the trail in good condition. Newer trails constructed in Ken-Caryl Ranch have been constructed using modern construction standards and have far fewer rolling grade dips because they have been constructed at sustainable grades.

Trails are never intentionally widened; it is our goal to keep them the same width they have always been. When maintenance work is performed to improve trail drainage, the temporary disturbance must be wider than the trail. When trails do get rutted, a common repair is to remove the outer edge berm, which then allows the water to properly flow off the trail. In both of these cases, the trail appears temporarily wider, but the vegetation grows back fairly quickly. Trails do tend to grow wider when users choose varying paths. This occurs when trail users choose to travel side-by-side or shortcut turns, or when the primary path is undesirable for some reason, causing trail users go around rocks, puddles, or mud in the trail. We do our best to recognize these situations and correct them. The recent work on Cougar Trail is an example of work to restrict users to a single path and eliminate shortcutting.

Often, trail maintenance work doesn't have the best appearance when it is first completed, but the visual impact softens and recovers over time, and that is part of the process of keeping well-maintained trails. Trail maintenance activities generate excess soil and must

remove some localized vegetation to be effective, creating a disturbed appearance immediately after maintenance activities. The vegetation will grow back quickly during the growing season; the visual impact is temporary, but the effect of the improved drainage features will last several years. The community standards for both trail construction and maintenance are that any disturbed zone will revegetate to a pre-disturbed state within one year. We have visited all the work that was done in this year's contractor maintenance work and feel confident this standard is being adhered to, based on our observations of past work and revegetation time. Trail work can be a bit messy, and it is not possible to maintain trails and have no visual impact.

When trail erosion leads to significant large rocks protruding above the trail surface, instead of removing rocks, which would lead to further erosion, best practice is to "armor" the tread by adding large flat rocks between the protruding rocks. This solution can be observed on several sections of KCR trails, including Colorow Trail, Lost Canyon Trail, South Shaffer Trail, and others.

The trail contractor that has performed maintenance for the past several years, Singletrack Trails, Inc, and their employees, are professionals working on projects all over the U.S. Trail maintenance and construction is their only business, and they use the most current sustainable methods. The work performed is never catered to a single user group. All types of trail users - hikers, runners, bicyclists, and equestrians - are considered when trail maintenance is planned.

It is especially helpful when trail users alert us to trail issues, such as fallen trees across the trail, erosion issues, or overgrown vegetation, so that we can correct these issues. Wildfire Evacuation Planning

To be prepared for a wildfire, it's important to be ready to evacuate quickly. This means monitoring alerts and warnings information, having a family communication plan, knowing evacuation routes, and having personal items and documents in order. This article provides additional information on wildfire basics, how to protect yourself and your property, and what steps to take now.

More and more people in Colorado are making their homes in woodland settings - in or near forests, rural areas, or foothill areas such as Ken-Caryl. There, homeowners enjoy the beauty of the environment but face the very real danger of wildfire.

Every year across our state, some homes survive - while many others do not - after a major wildfire. Those that survive almost always do so because their owners had prepared for the eventuality of fire, which is an inescapable force of nature in fire-prone wildland areas.

Planning for an evacuation should occur well before an emergency happens. A wildfire is a dynamic event, and time may be limited, so it's important for you to think clearly and act decisively during an evacuation.

Have A Plan

The first step in preparing for an emergency is to have a plan. Determine how you will respond to an evacuation order and make sure everyone in the home is familiar with the plan.

- Establish escape routes based on fire behavior.
- Have a back-up plan - Know two ways out of your neighborhood.
- Identify safety zones.
- Pre-determine a family meeting place.
- Plan and practice.

When To Evacuate

There are a number of ways that Ken-Caryl residents will be notified about an emergency. Most importantly - don't wait for an evacuation order. Consider early evacuation for the health and safety of your family. If you receive the notice to evacuate, it is important to respond immediately. Waiting, or choosing not to evacuate when told to leave, can put you and your family in danger. Some of the ways that information will be communicated to the public include:

- Local TV and Radio
- Official social media sites
- Emergency Alert System (EAS)
- Jefferson County Code Red
- Emergency personnel may not have time for door-to-door notifications

Preparing for Immediate Evacuation

As soon as you are alerted to an emergency in your area, follow these steps and be prepared to leave immediately:

- Back the car into the garage, roll the windows up, and leave the keys in the ignition.
- Close garage door and set it for manual operation.
- Load important documents, pets, valuables, evacuation kit, and prescriptions into the car.
- Take only one vehicle - stay together.

- Wear long pants, long sleeves, and sturdy shoes.

During Evacuation

Conditions during an evacuation can be chaotic. It is important to stay calm, think clearly, and avoid panic. Evacuating early and away from the

emergency is recommended; however, if you cannot safely evacuate, follow these guidelines:

- If you become trapped by fire, seek refuge in a structure.
- If you are trapped in your vehicle, park in a clear area, close windows and vents, and cover up with a blanket on the floor.
- If on foot, find a clear area, lay down on the ground, and protect your airway.

If You Have Time

If you become aware of a developing wildfire emergency, but your area is not yet directly affected, you may have time to take some action to increase your home's

survivability.

- Attach garden hoses to reach around the entire house.
- Fill sinks and tubs with water.
- Place a ladder against the house.
- Close windows and doors.
- Turn all lights on.
- Move furniture to the interior of rooms away from windows.

Pets

- In planning for an evacuation, don't forget to plan for your pets and livestock.
- Make sure pets have ID tags or a microchip.
- Make arrangements with neighbors in case you are not at home.
- Don't turn animals loose.
- Take pet supplies to last at least 72 hours.

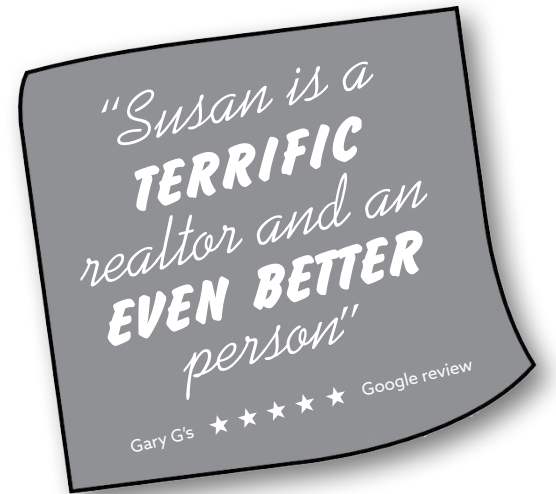

Emergency Kit - Plan For At Least 72 Hours

The 72-Hour Emergency Kit should be individually tailored to meet the basic survival needs of you and your family. Take into consideration any special needs such as infants and elderly, persons with disabilities, and pets. It is recommended that you store your emergency supplies in one location that is relatively safe, yet easily accessible and portable if evacuation is required. Rethink your kit and family needs at least once a year and replace items as needed.

After a Wildfire

Do not return to your home until fire officials allow for safe re-entry. Use caution when entering burned areas as hazards may still exist, including hot spots, which can flare up without warning. If you detect heat or smoke when entering a damaged building, evacuate immediately. Avoid damaged or fallen power lines, poles, and downed wires. Watch for ash pits (sunken holes which burned through), mark them for safety, and warn family and neighbors to keep clear of the pits. Contact your insurance company if there is any damage.

Master Association Board Approves Use of Class 1 e-Bikes in Private Open Space

At its May 21 Board meeting, the Master Association Board approved a change to the open space rules regarding use of electric bicycles (e-bikes) in Master Association private open space. Per the revised rules, Class 1 e-bikes are now allowed on natural surface and paved open space, greenbelt, and park trails. Class 2 e-bikes are only allowed on paved open space, greenbelt, and park trails. Class 3 e-bikes are only allowed on roads and parking lots where motorized vehicles are authorized to travel. The Metropolitan District Board will be voting on e-bike use in the South Hogback public open space at its June 25 meeting at 6 p.m. at the Ranch House.

Classification of Electric Bicycles

CLASS 1 - An electric bicycle that only provides assistance when the rider is pedaling; the motor ceases at 20 miles per hour (mph).

CLASS 2 - An electric bicycle that provides assistance regardless of whether the rider is pedaling; the motor ceases at 20 mph.

CLASS 3 - An electric bicycle that provides assistance only when the rider is pedaling; the motor ceases at 28 mph. Class 3 electric bicycles must have a speedometer.

Deer Confrontations in Brannon Gearhart Park

Rangers have received several reports of a mule deer doe charging at people in Brannon-Gearhart Park. This time of year, mule deer are entering the birthing season and are vulnerable to disturbance by both dogs and humans. Dog walkers are also urged to be vigilant, as female deer will act defensively during this time and have been known to attack dogs, even when the dog is at a distance and not provoking. Be sure to carry a walking stick or noise maker and clap hands to haze deer that are too close.

Remember, baby deer are born scentless; therefore, hiding fawns for the first few weeks of their life is the best way a mother can protect them from predators while they forage for food. Every year, there is a potential for baby deer to be killed by a loose dog, so mothers will act defensively if they spot dogs close by. Human contact can be just as devastating – touching, or even just approaching a baby deer, may result in it being abandoned by its mother and failing to survive. 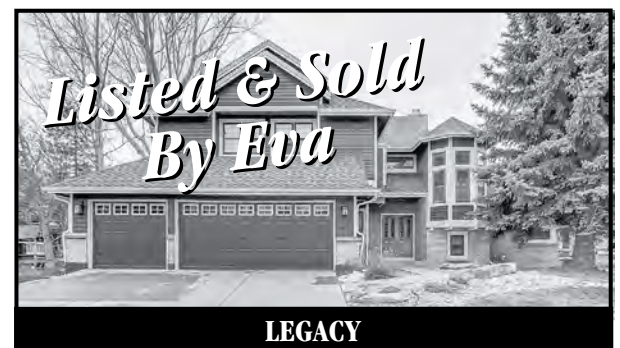

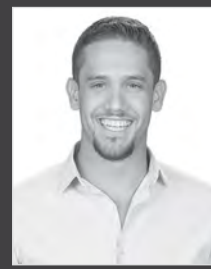

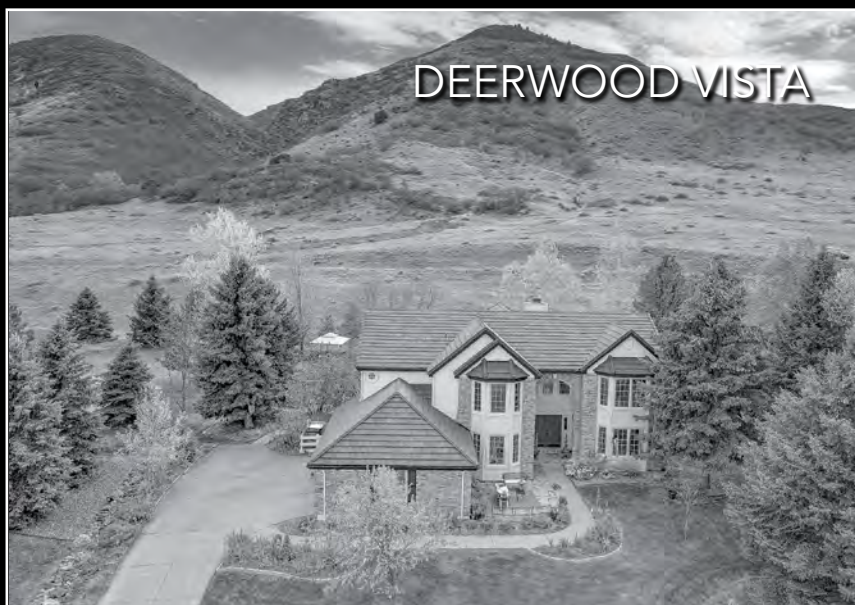
