Plains Metropolitan District Settlement Projects

By KCRMD District Manager Melissa Daruna In April, the Ken-Caryl Ranch Metropolitan District settled a 13-year lawsuit with the Plains Metropolitan District (PMD) for \$3.5 million. Many of you have asked what we will do with those funds and when. As you may have read, the settlement funds are for specific amenities: tennis courts, a pool or ballfields. In order to make providing these amenities for the community feasible, the language specifically allows the funds to be used on new or refurbished amenities. While the funds must be used on those specific facilities, the language is also intentional in stating that the Metro District will use the funds for tennis courts, a pool or ballfields. This allows the Metro District some flexibility in allocating the funds for the maximum benefit of the community.

The PMD made the first payment of \$770,000 almost immediately after the settlement was final. We will receive another payment of \$278,000 this year and subsequent payments of \$300,000 annually until the total is reached. The Metro District Board has identified the first two projects to fund – courts 1 & 2 at the Community Center and the Ranch House Pool. Courts 1 & 2 at the Community Center were originally part of the bond projects.

A water line easement set the timing back on those and funding was needed in other areas of the site. As a result, courts 1 & 2 were put on hold. Subsequent funding was acquired from the Master Association to help make the court renovations a reality this year. The resurfacing should be completed by the end of the month. The first use of the PMD settlement proceeds will be to pay back the Master Association and the Metro District operating fund for these courts.

The second project will be a muchneeded renovation of the Ranch House Pool. Plans will begin this summer and fall to establish the actual construction costs of the project. The intention is to begin construction as soon as possible but that will be determined by when the funds are available. Our initial goals are to expand the pool slightly to allow for eight lanes, which provides more space for the public and better accommodates the incredibly successful Ken-Caryl Swim Club. More deck and seating space with adequate shade is also on the project list. As plans take shape, we will be sharing them with the community and taking feedback.

The last amenity is ballfields. There has been discussion of purchasing land, funding a project at Bradford K-8 North or just renovating the fields we have. Some of this discussion has sparked strong concern from residents. Given that there was no immediate answer as to what the community needs in way of new or just refurbished ballfields and/or where more fields should be located, the Metro District Board has decided to wait until the tennis court and pool projects are finished to discuss ballfields. Additionally, because not all \$3.5 million is available at once, not all projects can be considered or completed at one time. The Board will need to evaluate how much, if any, funding will be available once the pool project is complete, before they can revisit building or refurbishing ballfields. At that time, we will be sure to involve residents to establish what the community wants and needs.



Out In the Yard

As I tour the neighborhoods this season it is lovely to see such beautifully manicured lawns and carefully tended landscapes. I see you out there working in your flower beds. I see your kiddos out earning their allowance with that lawn mower. The trash cans are overflowing with branches and trimmings. The streets are filled with landscaping trucks. I see you doing your part! Thank you so much for all you do. Your hard work shows in your gorgeous yards!

Unfortunately, I've also noticed that some yards haven't quite been tended to as they should by now. I'm afraid they tend to stand out like a

sore green thumb! The Master Association is now inspecting for yard maintenance for the season. Please take a look at your lawn, the rock and flower beds, shrubs, and the condition of your trees. Is it time to mow, weed or mulch? Bare spots in the grass? These are some of the things we look for this time of year. Please take this reminder as an opportunity to take stock and execute a plan!

There are some residents in our community who may not be able to do some of this basic maintenance on their own. Is there an opportunity in your neighborhood where you could make someone's day by helping them out? Maybe the elderly couple down the street would love nothing more than to pay your kiddo to mow for them, too. The disabled veteran next door may really appreciate it if you weeded his rock bed while you were already weeding your own. Little kindnesses can go a very long way.

Here are the Rules for Landscaping per the Home Improvement Rules and Regulations (page 12):

3.23 Landscaping. (See Landscape Guidebook for landscape planning suggestions) Any form of landscaping, such as retaining walls, sidewalks, gravel, rock, impervious surface material, structures, grass, trees, and shrubbery shall have Committee approval prior to installation, and thereafter be carefully maintained. The Committee seeks to achieve an aesthetically pleasing balance of turf, planting and hardscape material within the lot and neighborhood. Consideration should be given to plant materials that do not require excessive water and to locating plants away from buildings to avoid excessive moisture around foundations. Submittals shall include complete descriptions of materials and colors, including plantings and dimensions, as applicable.

All yards shall be kept free from plants infected with insects or diseases, which in the opinion of the Committee, are likely to spread to other areas.

All yards shall be kept free from weeds. No perimeter concrete edging is permitted, except to delineate planting beds. Submittal shall include color of concrete edging to coordinate with predominate ground material in planting beds.

Joint Study Session

On June 6, the Ken-Caryl Ranch Master Association and Metropolitan District Boards held a Joint Study Session and discussed the following items:

- The Boards discussed the use of facilities by Plains Metro District residents and business owners.
- The Boards discussed the planned uses for the Plains Metro District lawsuit settlement money. The Metro District Board plans to use the lawsuit settlement funds to pay for Tennis Courts 1 & 2 at the Community Center that are scheduled, weather permitting, to open the week of June 19. The settlement proceeds next will be used to replace the pool at the Ranch House. If there are funds still available after the pool is complete, the Metro District Board will consider renovating or developing ballfields at a later date.
- Staff gave an update on the community survey development by the Community Planning Committee. The CPC will present the draft survey to the Boards at the July Study Session.
- The Boards discussed turf reduction areas leading into the North Ranch.
- Staff provided quotes for an updated HVAC unit for the Shaffer Room at the Ranch House. The Boards directed staff to move forward with the replacement.

Be Aware of Ticks When Enjoying the Trails and Open Space

While encountering ticks in Colorado is not uncommon, the number of times that the Rangers working in Ken-Caryl Ranch Open Space have found ticks on their bodies is relatively rare. However, I was reminded recently when hiking at Chatfield Reservoir that ticks are indeed a part of our environment when I found four ticks "attached" to my dog. Experts are predicting an active tick season in 2017 due to warmer temperatures. The information below from the Colorado Cooperative Extension Service provides important information about ticks, including ways to avoid them when enjoying the outdoors this summer.

- In Colorado, Rocky Mountain wood tick and American dog tick are the most common ticks associated with people.
- Colorado tick fever is by far the most common tick-transmitted disease of the region. Despite its name, Rocky Mountain spotted fever is quite rare here.
- No human cases of Lyme disease have originated in Colorado.
- DEET is the most effective tick repellent.
 Apply it to pants or other areas of the lower body.
- To remove a tick, grasp it with blunt tweezers, as close to the skin as possible. Ticks are blood-feeding parasites of animals found throughout Colorado. They are particularly common at higher elevations. Problems related to blood loss do occur among wildlife and livestock, but they are rare.

Ticks are most important because they can transmit diseases such as Colorado tick fever, Rocky Mountain spotted fever, tularemia and relapsing fever. Lyme disease is an important tick-borne disease in much of the eastern United States. Fortunately, ticks known to transmit it are not known to occur in Colorado, and no confirmed cases have originated in the state.

Avoid traveling through areas where ticks are abundant. Ticks are most active in spring and early summer and concentrate where their animal hosts most commonly travel. This includes brushy areas along the edges of fields and woodlands or commonly traveled paths through grassy areas and shrublands.

Use Tick Repellents

There are a few effective tick repellents. By far the most common is DEET (N,N-diethyl-metatoluamide), the active ingredient in most common insect repellents, such as Cutters and Off!. Apply DEET directly to the skin or to clothing. Repellents are most effective if applied to pants and other areas of the lower body likely to come into contact with ticks.

DEET can be an effective repellent for ticks as well as other biting arthropods, such as chiggers and mosquitoes. However, the following precautions are encouraged:

 On children, do not use high concentration formulations (above 30 percent).

- 2. Apply the repellent to clothing, rather than to skin.
- 3. Do not apply DEET to hands or other areas that may come into contact with the mouth.
- 4. Do not apply to wounds or irritated skin.
- 5. After use, wash or bathe treated areas, particularly on children.

Permethrin (Permanone) is a new tick product. Apply it only to clothing, not to skin. It can kill ticks rapidly. Permanone also may have some repellent activity against ticks.

Wear Protective Clothing

Long pants, long-sleeved shirts and other clothing can help exclude ticks or keep them from attaching to the skin. Ticks are usually acquired while brushing against low vegetation, so pulling socks over the bottom of the pants leg also is useful. Light-colored clothing can make it easier to find ticks that have been picked up.

Conduct Tick Checks

Ticks take several hours to settle and begin feeding. This gives you ample time to detect and remove them. The Rocky Mountain wood tick typically takes 12 to 24 hours to start feeding. Therefore, a thorough "tick check" can be an effective alternative to repellents. After walking through areas where ticks might be present, carefully look for and remove any ticks you may have picked up.

Controlling Brown Dog Ticks in a Home

Unlike the more common ticks (American dog tick, Rocky Mountain wood tick), the brown dog tick spends most of its life around the dog host. It is a subtropical species that cannot survive outdoors year-round in Colorado. Infestations most often develop in protected areas, such as kennels. After they have taken a blood meal, adult ticks may crawl up walls and lay eggs in cracks and corners of the room.

Treatment of the dog is essential, using one of the many flea and tick powders, dips or collars. However, areas that the dog frequents, such as bedding and resting areas, also need to be treated to kill residual ticks. Vacuum cracks along baseboards where ticks may hide and spot treat these areas with insecticide. Discard the vacuum bag and contents after treatment

If possible, wash bedding and all other materials. Because these ticks are sensitive to cold, storing infested items outdoors during very cold temperatures also can kill these ticks. It may take several weeks and multiple treatments to eliminate brown dog ticks.

Once a tick has become firmly attached to the skin, removal can be difficult and should be done with care. The mouthparts are barbed, so they may remain after removal and allow infection. Fortunately, the Rocky Mountain wood tick, the most common species found in Colorado, is relatively easy to remove because it has fairly short mouthparts. The recommended procedure for removal of ticks is:

- 1. Grasp the tick with blunt tweezers, as close to the skin as possible. If tweezers are not available and you must use your fingers, cover them with tissue or thin plastic to avoid the possible transmission of any disease organisms, such as tularemia, that the tick may harbor.
- 2. Pull the tick slowly and steadily, straight away from the skin. Try not to crush the tick as you remove it.
- 3. After the tick is removed, treat the feeding site with a disinfectant. Wash your hands when done.

Many other methods have been popularized to remove ticks, such as covering them with petroleum jelly or touching them with a hot match. These methods are not effective.

A rare but potentially serious condition from tick feeding is tick paralysis. This occurs when certain ticks (in Colorado, particularly the Rocky

particularly the Rocky Mountain wood tick) remain attached for a long period and produce an ascending paralysis.



Early symptoms, such as difficulty walking, progress to more generalized symptoms, such as limb numbness and difficulty breathing. This condition is completely reversible when the tick is removed.





Fencing and Deer Ramps Along C-470

In May 2016, the Colorado Department of Transportation (CDOT) began a project to resurface C-470 from south of the I-70 and C-470 interchange to Exit 10 at Ken Caryl Ave. This infrastructure and maintenance project also included some wildlife safety improvements that are nearing completion. The resurfacing was designed to restore the current pavement, add an overlay of asphalt, repair several bridge joints and apply new pavement markings along the length of the project.

Additionally, 15 deer escape ramps and more than 7,800 linear feet of new wildlife fencing was installed. CDOT uses 8-foot high wildlife fencing in conjunction with wildlife crossing structures to keep animals off the road while allowing wildlife safe crossing opportunities and connectivity to habitat.

Despite these efforts, wildlife sometimes enters the highway right-of-way. The deer escape ramps are designed to provide a safe way for wildlife to exit the road rightof-way and to create a barrier that discourages them from entering the highway. This project was a great way to ensure the highway is safe and durable for years to come, while doing so with minimal impact on both commuters and wildlife.

Jefferson County is sponsoring slash collection days for wildfire mitigation throughout the summer across the county. Ken-Caryl residents can take steps to protect their property and help alleviate the spread of wildland fires by minimizing the fuels – both man-made and natural – around their homes. Many Coloradans living in the plains and foothills areas need to consider the fire-prone nature of these ecosystems.

Due to Colorado's arid climate and firedependent forests, many homeowners and landowners may be particularly vulnerable to wildfires. Wildfire is unpredictable. Nearly 20 percent of the average home hazard could be reduced by taking relatively simple mitigation measures such as moving flammable material away from homes. Consider using this opportunity provided by Jefferson County to reduce the risks to your home and family. For more information visit: jeffco.us/slash/

From Jefferson County:

Clear your property and bring your tree debris to the Jefferson County Slash Collection! We'll be somewhere in Jefferson County every weekend through Nov. 12.

Slash is debris, from nature, such as tree limbs, prunings and pine needles. If not removed, slash can add to potential fire hazards on your property. The importance of mitigating and preparing your property for wildfire cannot be understated - and again this year, Jefferson County is your partner in this effort.

Removing slash and creating a defensible space around your home is the

first line of defense against wildfires. You can create zones around your home, removing any fire fuels, such as tree debris.

Having a properly mitigated property doesn't mean that wildfire will pass you by, but it gives the fire department a better opportunity to save your home when it does come. Great tips on how to protect your home and property can be found at www.firewise.

What is accepted?

- Slash limbs, branches and tree debris
- Maximum length 8 feet
- Maximum diameter 6 inches
- Pine needles, tree bark and pine cones, bagged or unbagged
- In addition, leaves accepted at the Thunder Valley Park location only What is NOT accepted?
- · Household trash
- Tree stumps
- Construction material and lumber
- · Metal material of any kind

 Fees for Slash Drop-off

Any size truck or trailer is welcome at Jefferson County Slash Collection sites. Dump fees are based on six cubic yards (162 cubic feet) of material: 6 yards = 1 load. The cost to drop off a single "load" is \$20. Credit cards only.

This is equivalent to:

- Truck bed full to truck cab height
- Trailer up to 8' length x 5' width x 4' height
- Loads outside these parameters will be charged accordingly

The fees that are charged help to offset the cost for the processing equipment, staffing and keeping the program sustainable so it can continue into future years.

Resident Lisa Downing Receives Third Emmy Nomination

Internationally acclaimed concert pianist, composer and recording artist Lisa Downing, a Ken-Caryl Ranch resident, received her third Emmy Nomination for Musical Composition / Arrangement of her song, "The Torii Gates" featured in a video by the same name created by Enchanted Road Productions of Golden, Colorado.

In addition to another walk on the Emmy Award Night Red Carpet at Wings Over the Rockies on Saturday, July 15, Lisa will be traveling to the Portland, Oregon Japanese Gardens, for a commemorative ceremony celebrating the return of the Torii Gates to their home in Hachinohe, Japan.

The story behind the song and video "The Torii Gates" begins in a small Japanese fishing village with sacred Torii Gates, which were designed to impede the flow of evil spirits and ensure the safety of the fishermen as they sailed to their oftendangerous work. The village of Hachinohe was devastated by a powerful earthquake and ensuing tsunami that swept the gates out to sea. Months later, the Gates washed ashore on the coast of Oregon and were taken to the Portland Japanese Gardens where they were identified, repaired and later returned to the village in Japan to experience an amazing resurrection.

This is a story of contrast and connection between two very different cultures as well as the many people and organizations who participated in the repatriation of this symbolic structure.

Lisa performs world-wide with Grammy Award winning musicians, and her most recent album, "The Wisdom of My Shadow," achieved No. 5 on the Billboard Charts, was selected for first-round Grammy consideration and was nominated for Best Piano with Instrumentation by radio programmers at the international radio reporting site, Zone Music Reporter.



The Vinyls

Band Made Up of Residents Entertains at Local Venues

Who are the Vinyls? Well if you were one of the people who were able to squeeze into G.I. Jodi's Bar and Grill on West Meadows May 6 you probably already know. The Vinyls are a band, a Ken-Caryl band, that has a special affinity to their community.

"We're from Ken-Caryl. We love it here, and this is a special place," said member Bill Tepley. "Why should we run all over town, playing crazy hours, in crazy places when we have the best fans right here in our friends and neighbors."

The Vinyls attempt to cater to those fans by playing at local venues like G.I Jodi's and by tailoring their playing times to mirror the schedules of the locals.

"We're all parents. We know there are swim meets and soccer games in the morning, so we try to play close, to start earlier and end earlier. It's a courtesy; we know our peeps," said Susan Boyle, who along with her husband, Brian Boyle, are cofounders of the band. Brian and Susan's musical collaborations go back to their college days and have carried on with their children; son Nick even played drums with the band until his college graduation. The Boyles would throw summer backyard jams and invite friends and neighbors to come play.

"We had a feeling there was some local talent," Brian said. Brian spotted his neighbor, Bill, who lives around the corner, with a bass guitar one day and asked him to join the group for a jam. Bill, who had played guitar in several local blues bands, had just picked up the bass.

"I was actually coming home from my second bass lesson when Brian spotted

me. The next day he brought me about 40 pages of music from their set list. He was persistent; he kept asking me to come jam. So I learned the two easiest songs on the list and went up to make a fool of myself. Two songs later the Boyles said, 'welcome to the band."

"That's when things started getting a little louder," said Brian. John Soukup, who lived about four houses away from Brian, came on to play lead guitar and then Brian found a true musical gem right under his nose. Boston transplant and Jazz trained saxophonist Michael Kelly is Brian and Susan's next-door neighbor. Michael has his own CD out from his time touring the Eastern Seaboard with his Jazz quartet. When asked if he'd consider playing with the group he responded with a "Sure, why not?" Not only does having a skilled sax player give the band a unique soulful feel, but Michael also plays harmonica and flute with the group.

Six band members within a one-block radius; who could ask for anything more? "Tepley could," said Brian. "Bill dug his heals in about our old name, Mid-Life Crisis. Literally he had a crisis about Mid-Life Crisis. We had a band meeting with adult beverages and came up with the Vinyls. It mirrors our music and a time when you used get with your friends and spin records."

"In a sense, not much has changed," said Bill. "We're still getting together with our friends and playing music."

The Vinyls play rock and roll. "Rock and Rollish," said Bill. "We play anything from Carl Perkins and Johnny Cash to R.E.M. and the Wallflowers, and there's always a heavy dose of the Beatles, the Rolling Stones, Linda Ronstadt, Van Morrison and Tom Petty; you know, the fun stuff."

"We love their music," said Jodi Malloy, owner of G.I. Jodi's. "They're one of the bands that I will actually stay and listen to. There's no 5-minute epic guitar solos, no foul language; just fun to dance to or fun to sit back and visit with your friends to music. And they have such a great group of fans that follow them."

John and Nick have moved on, but the Vinyls' fortune has continued. Greg Horner has taken up the seat vacated by Nick behind the drum kit and has expanded the back-line sound of the band. Greg's mantra has been, "I wanna play some music!"





Free App Launched to Help Homeowners Determine if Trees are Susceptible to Emerald Ash Borer

To help Colorado homeowners determine whether trees on their property are susceptible to being killed by emerald ash borer (EAB), the Colorado State Forest Service and Colorado State University Extension released a free app that will allow anyone to use their mobile device to quickly ascertain whether a tree may be a potential target for the pest.

EAB is a highly destructive, non-native insect from Asia, first detected in Colorado in 2013, which is fatal to all infested ash trees unless the trees have been chemically treated.

"The most important thing Colorado communities can do now is prepare for emerald ash borer's arrival by increasing their EAB awareness, sharing information about how to identify ash trees and learning the symptoms of this pest," said Keith Wood, CSFS community forestry program manager.

The EAB/Ash Tree ID app can be downloaded on almost any modern Apple or Android-based device, and easily located in app stores by simply searching for "ash tree." It offers a stepby-step process to determine if a given tree appears to be a true ash or not, and

offers links and other information about EAB for users who suspect they might have an ash tree. The app is intended not just for homeowners, but also for business owners, school groups or anyone concerned about the potential impacts of this pest.

The app also is intended to prompt homeowners and other landowners to consider early management options for EAB. These may include replacing unhealthy trees before they die, treating high-value trees with the proper insecticides and planting new trees near ash that might ultimately succumb to the

EAB, which is responsible for the death of tens of millions of ash trees in 30 states and two Canadian provinces, has only been detected in Boulder County within Colorado. Yet the pest has become a concern for communities all over the state because each year it can fly up to a half mile to infest new trees. It can also spread much faster through the human transport of firewood and other raw wood. An estimated 15 percent or more of all urban and community trees in the state are ash, which are susceptible to EAB.

Boulder and Longmont have been dealing with the pest's impacts since having confirmed detections, while many other Colorado communities are preparing for EAB's arrival. The City of Denver began its "Be a Smart Ash" campaign last year to raise awareness of the EAB threat in the metro area, where one in six trees are ash, and since then has been implementing a 15-year plan to identify, treat and replace ash trees on city property.

What Coloradans **Need to Know**

- · Learn how to identify true ash
 - o compound leaves with 5 to 9

Emerald Ash Borer:

- o leaflets, buds and branches growing directly opposite from one another
- o diamond-shaped bark ridges on mature trees
- Know the signs of EAB infestation in ash trees:
- o thinning of leaves and upper branches and twigs
- o serpentine tunnels produced by larvae under the bark
- D-shaped exit holes 1/8-inch
- new sprouts on the lower trunk or lower branches
- o vertical splits in the bark
- o increased woodpecker activity
- Multiple EAB management strategies exist for homeowners and communities, including monitoring trees for the early presence of the pest, removing and/or replacing ash trees, protecting trees with insecticides and planting different species of trees nearby in an effort to get them established before the arrival of EAB.
- If hiring someone to apply pesticide treatments to protect ash trees, the applicator must be licensed by the Colorado Department of Agriculture as a Commercial Pesticide Applicator.
- Never transport firewood or other products from ash trees, as this is the most likely method of accidental spread. A quarantine is now in place in Boulder County and surrounding areas to try and prevent the human-assisted spread of EAB.


