The District and Master Association Boards along with management and staff are working with the bond project contractor, Adolfson & Peterson, to coordinate the construction efforts to minimize impact to users of the facilities during the upcoming construction projects. Preaching to the Choir

Many residents don't take the time to read this column, so the information trying to be conveyed often doesn't reach those who might benefit. I truly appreciate people who show an interest in learning different aspects of our governing documents, as there are misleading or creative interpretations out there that can spawn problems among neighbors. Certainly our documents strive to create a sense of community and to facilitate resolution of issues.

I am periodically disturbed to receive complaints from residents that make it clear they don't know their neighbors. Too many times a caller cannot even provide the first names of a neighbor as I attempt to verify information. While one of the purposes of my job is to address neighbor-to-neighbor complaints – often anonymous – sometimes the result is an escalation of the issue. There are many reasonable owners who would resolve a problem the first time a neighbor brought it to their attention.

It's easy to understand with our busy lifestyles how a resident may not be aware of a problem unless someone calls it to their attention. Hearing about it from an "official" letter that I send can sometimes cause an owner to react negatively due to being caught off-guard or feeling threatened or embarrassed. That being

said, I would not want to discourage anyone from contacting me if assistance is needed or if they do not feel comfortable addressing a neighbor directly.

I chose the timing of this topic because Tuesday, Aug. 4 is National Night Out. A casual gathering of the neighbors on a block can do wonders to ease some existing barriers and promote a sense of belonging. I would suggest inviting your neighbors to spend perhaps one hour outside after dinner that night, bringing a chair into someone's driveway to visit while the kids play with their friends. Don't make it anything elaborate like a block party or a holiday event, as you will automatically limit participation by people who don't have time or interest in a pot luck or can't devote a full evening to a gathering. People who know and feel comfortable around each other will naturally make better neighbors and have better neighbors.

Please keep in mind that rules are dynamic in nature...new issues surface, obsolete rules are deleted and others are amended or updated. Ranch House Construction Phasing

Early planning for the implementation of construction is underway with Adolfson & Peterson, the design team and Ken-Caryl Ranch. One of the challenges on the Ranch House project is performing construction activities within an occupied facility. This means that A&P will need to manage the noisy work to minimize the impact on staff, youth programs and residents using the facility.

The KCR staff have proactively blocked off time on the reservation calendar for the Adult Lounge to prevent events from being scheduled during construction renovations. The team's goal will be to reopen the Adult Lounge at the completion and inspection of all construction activities.

Working within an occupied facility requires a high level of communication and attention to safety. Communication of work areas will inform staff and residents of what changes are happening and when they will be happening. The Ranch House interior renovation is anticipated to occur within three phases.

The first phase will include renovations to the Adult Lounge on the second floor and the Map Room and A/V Room on the first floor. Including the Map Room and A/V Room in the first phase of construction provides for transitional space or 'swing space' for staff to operate from while other areas are under construction. Including the Adult Lounge in the first phase will minimize the amount of down time for this



important and highly utilized space. Take note that regular events like Board meetings will likely have alternate locations during construction activities.

The second phase of construction will include the staff office areas. This area is being reorganized for a more efficient layout, with fewer private offices. Once the staff area construction is complete, the recreation end of the Ranch House will be the third and final phase of interior renovations. During the recreation area renovations, the Map Room and A/V Room will likely be used by the youth programs.

Your familiar routine for accessing services within the Ranch House will be altered during construction. Please take note of signs placed at entrances and around the work areas to find temporary locations of staff and programs. The larger area we can provide for A&P to work in, the greater amount of work they can complete in each phase.

Tree Information

Dead Tree Removal in Parks and Greenbelts

Weather conditions recently have caused hardship to many trees on Ken-Caryl Ranch resulting in an unusually high number of dead trees. The Ken-Caryl Ranch Rules and Regulations states that landscaping should be carefully maintained. This spring the Master Association sent out a number of letters to residents who have dead trees. We appreciate those of you who have acted quickly and removed or scheduled the removal of your dead tree.

In response to receiving a letter, several homeowners have expressed concern about dead trees in greenbelts and parks. The Ken-Caryl Ranch Metropolitan District is responsible for the maintenance and removal of trees in these areas. The plan for addressing the issue is as follows:

The District Forestry Technician and his assistant are somewhere on Ken-Caryl Ranch on a daily basis removing dead and dying trees. The combination of the age of many of the trees on the Ranch and the weather conditions over the past several years have created a large backlog of trees that either need to be trimmed or completely removed.

The District has prioritized the most egregious of the dead and dying trees with the highest priority for attention being those trees that are considered hazardous to humans and property. The list of priorities is reviewed on a regular basis with the staff, who continue to move through the list during the regular course of their work week. The combination of the tree removal and replanting is an ongoing operation that will continue throughout the winter months.

Open House for Saddlewood and Territory Park Improvements

Join us Wednesday, July 29 for an open house to review plans for park improvements, playground replacement, landscape modifications and irrigation replacement for the Saddlewood and Territory neighborhoods. This comeand-go style open house is from 4:30-6:30 p.m. at the Ranch House. Plans will be posted online after the meeting.





Master Association Board

The following is a summary of items from the July 21 business meeting of the Ken-Caryl Ranch Master Association Board:

- At the request of the KCRMD Board, the MA Board reviewed and provided comment on conceptual plans for replacing the Ranch House Pool as potentially part of the settlement of the Plains Metropolitan District lawsuit.
- The Board received a request from neighbors to install a light in the Brannon Gearhart Park parking lot. It was decided that the expense was greater than the value, and the Board voted not to fund the light installation.
- The Board reviewed a proposal to extend the Waste Connections trash and recycling contract for another five years and directed staff to develop an RFP to solicit competitive bids for this service. In addition, bidders will be asked to provide an alternate cost to collect compostable materials.
- The Board began the 2016 budget discussion.
- The Board discussed the possibility of adding a guard rail on Ken Caryl Ave. near the Massey Draw stream stabilization project. The rail would help protect trail users. This project will be included on the list for possible funding in 2016.
- The Board reviewed a proposal from Muller Engineering for erosion and drainage controls in the open space behind 93 North Ranch Road. Staff was directed to solicit a proposal from Muller to investigate the possibility of engineering to direct water past the culvert on Crestbrooke Drive to keep water off the open space behind this property.
- The Board reviewed the status of Reserve funding in the second quarter.
- Staff discussed the status of 2nd quarter goals with the Board.
- The Board reviewed the Conflict of Interest Policy.
- The Board approved a request from the History Committee to provide additional funding from the 2016 contingency line item in the amount of \$7,500 to make maintenance repairs to the Bradford Perley House.
- Manager's Report: A written report was included in the Board package.
- Committees: Reports were included in the Board's meeting package.
- A motion passed approving the Open Space Committee's recommended design of the Upper Cougar Trail.

 A motion was approved adopting the Landscape Master Plan as presented at the May Joint Study Session.

Joint Study Session

On July 14, the Ken-Caryl Ranch Master Association and Metropolitan District Boards held a Joint Study Session at the Ranch House and discussed the following items:

 The Boards received a request from the District tennis staff suggesting that they consider installing Pickleball Courts at the Community Center as part of the Bond Projects or sometime in the near future. This is reported to be the fastest growing sport in America. The Boards indicated they would take the request under advisement and direct the Community Planning Committee consider Pickleball Courts in its planning for possible future amenities.

 Vanir Construction Management and Adolfson & Peterson Construction presented an update on the status of the Bond Projects including 100 percent Design Development pricing. The project costs are very close to budget now. It is anticipated that the combination of some minor scope reduction and value engineering will be able to reduce costs to fit within the budget.

- The prospect of replacing the pool at the Ranch House as a part of the Plains Metropolitan District lawsuit settlement was discussed. The MA Board will include this topic on the agenda for their July Business meeting and relay comments to the MD Board.
- Staff updated the Boards on the schedule for work on Saddlewood and Territory Parks to be presented to the community at the July 29 Open House. In addition, ideas for Heirloom, Dakota Lodge and Bradford Parks were outlined.



Friends and Relatives of Members Recreating in Open Space

The Park Rangers are charged with enforcing the Ken-Caryl Ranch (KCR) Open Space and Parks Rules adopted by the Master Association and Metropolitan District Boards. Rule No. 1 states "Private open space properties are for the use of members and their guests only. Guests must have a pass or be accompanied by a member. Trespassers will be prosecuted."

KCR private open space is owned by the Master Association, and management costs are covered by Association dues. No public money was used to purchase the property or manage it, and the community is not obligated to provide access to the general public. This is quite different from the typical open space property managed by federal, state or county agencies.

When using the private open space areas of KCR, visitors must be prepared to prove their residency. When contacted by a KCR Park Ranger in private open space, you will be asked to:

- Provide your property address and/or a picture ID
- Display a Ken-Caryl Ranch Open Space ID Bracelet

Trespassing does take place in the private open space. Non-members are drawn to our open space because the incredible scenery, diversity of trail experiences and relatively light visitation that limits trail user conflicts.

Sometimes the Rangers will come in

contact with an individual who is not a KCR member but he/she explains they are either friends of a member or they are family/ friends staying with a member. This of course is not allowed unless, as the rule states, they are accompanied by a resident. Park Rangers have no choice but to issue a contact notice for trespassing.

The contact notice unfortunately will put the individual on notice for the next 36 months. If they receive another contact notice for trespassing, Jefferson County Sheriff will be notified and asked to issue a summons for trespassing. The Ranger staff does not have an option in enforcing the

rules as they are set by the elected officials, the Ken-Caryl Ranch Board of Directors.

One helpful option for family or friends not living on Ken-Caryl Ranch and wishing to visit the open space is to request a Guest Pass through the open space manager. The purpose of this pass allows friends or relatives on a short-term basis to be in private areas without being accompanied by a resident. The introduction of this guest pass has helped reduce confusion during contacts for Rangers and users alike. If you would like more information, please call the Rangers at 303-979-1876, ext. 170.
