Pool Update

Greetings from your community managers! Given the importance of pools to the Ken-Caryl Ranch community, both of us wanted to provide an update regarding pools. We have greatly appreciated everyone's patience this summer in the ever-changing world of COVID restrictions, safety precautions, new processes and pool closures.





Many residents have asked why only one pool opened this summer. In May, the Metropolitan District Board voted to open the Community Center pool after soliciting community input when state rules would only allow 10 occupants at the pool at any given time. The easy and safe decision for the MD Board at the time would have been to not open any pools, which was the path chosen by many other public and private entities. Many residents supported not opening pools at all, but the MD chose to open the Community Center pool, recognizing the importance of aquatics to this community.

In May when this decision was made, staff and the boards believed the new Ranch House Pool would be finished by mid-July, thus providing a second pool for community use this summer. With the MD's considerable financial constraints due to significant COVID-19-related loss of programming income, opening all three pools was not deemed fiscally responsible. Thus, the difficult decision to not open the Bradford pool was made.

There have been numerous Ranch House pool construction delays due to weather, COVID-19 and structural issues with the building addition. The contractor informed staff in mid-July that construction will likely not be completed on the Ranch House pool until the end of August, which may not allow enough time to train lifeguards and open before the end of the season. If we are able to open, even for just a few days, we have a plan in place. It will likely be a week-to-week decision based on the construction schedule, so please stay tuned to our social media channels and the website for updates. While this is not the news staff or the boards were hoping to share with the community, good news is we will have a solidly built, amazing new pool when it is completed.

Staff has also been asked by several residents why the pools require lifeguards and are open to the public. While the Ranch House and Bradford Pools are owned by the Master Association, which is a private HOA, the MD, which is funded by taxes, operates these two pools. The MD also operates the Community Center pool, which is owned by Jefferson County. When tax dollars are used to operate an amenity, that amenity must be open to the public. Public swimming pools are required to provide a safe and secure environment, which includes lifeguards and other measures such as signs, inspections and the correction of dangerous conditions. While many HOA pools operate without lifeguards, all three Ken-Caryl Ranch pools are considered public because the MD is responsible for all operations.

to improve sound quality for remote participation at board meetings. Ranger Matt Oven presented the annual Open Space Statistics. The trespassing rate on the trails for January to June was 1.2% in 2019 and 1.6% in 2020. There was a significant increase in trail users, but not a significant increase in the trespass rate. Volunteer Trail Coordinator Mark Celusniak presented a trail safety

- reroute of the Mastodon and Lyons trail, designed to create a safe crossing of Ken-Caryl Avenue at the stop light. The Board expressed support for the safety reroute and directed the Open Space Committee to review the plans and prioritize the elimination of the existing dangerous crossing. The Board requested the reroute be shared with the community for feedback.
- Resident Jim Fodor expressed concerns about trespassing on the trails, bicycle activity on the trails and the proposed trail reroute.
- Resident Cathy Packard expressed concerns about Metro District parks maintenance, budget priorities and staffing reductions.
- Resident Rilla Reinsma expressed concerns regarding the original design of the Lyons and Hogback trails.
- Victoria DeSair presented the Reserve Plan update.
- Scotty Martin reviewed the KCRMA Board priorities including community input, assessments, a capital investment plan and community safety.

 Life at Ken-Caryl August 5, 2020 By Park Ranger Matt Oven

Out of Yards

The Rangers recently received a report from a resident witnessing a couple of young males discharging a suspected pellet gun from a house at deer in the neighboring property and then into the open space. This type of activity is considered harassing wildlife since the deer were not causing a problem in the person's yard. Plus, targeting wildlife in this manner can cause severe injury and even death while discharging a pellet or BB gun at them. Parents, we encourage you to talk to your children and teach them the correct way to deter wildlife from the area. Here are a few helpful tips to share with them:

The safest way to deter nuisance wildlife is being able to "haze" the animal out of your property, or if too close to you on the trail while recreating.

- If approached by a coyote or fox, do not run or turn your back on it. Be as big and loud as possible.
- Wave arms, clap hands and yell in an authoritative voice.
- Turn on sprinklers or spray with a garden
- Throw rocks, sticks, tennis balls or anything else you can find at the body or rear of the animal, not the face.
- Bang pots and pan together.
- Sling a rock using a slingshot.
- · Turn on flood lights.
- Shake or throw a shaker can, which is a soda can filled with pennies or pebbles and sealed with duct tape.
- Make noise with an air horn, whistle or other noise makers.



- Spray pepper spray or citronella spray such as Sprayshield product.
- Use a paintball or airsoft gun on base level to scare them off. The intent is to scare, not injure them.

If animals are staying in yard overnight in specific area

- Remove any ATTRACTANTS, pet bowls/ food, bird feeders, hummingbird feeders, fallen fruit, food from vehicles, remove/ clean dirty grills and trash, clean out garbage cans/store in garage.
- Trim bushes/trees, mow tall grass, remove any brush piles so as to eliminate cover for animals.
- Place bright light by the area at night.
- Throw dog scat, or rags/tennis balls soaked in ammonia by the area.
- Place a loud radio (or other sound producing device) by the area.

The main goal is to make mammals that are a nuisance to humans uncomfortable and to instill in them the fear of humans so that they leave the area. If you have any questions, feel free to email matto@ kcranch.org or call the rangers at 303-979-1876, ext. 170.

Mullein - You're not Welcome Here!

Have you seen people on the trails and in the open spaces with shovels in hand, digging something? They are part of the Ken-Caryl Weed Warriors who have declared war on the highly invasive and noxious weed, common mullein, and you can help too!

Common mullein is a biennial plant (a flowering plant that takes two years to complete its life cycle) that is native to Eurasia and the Mediterranean, but does not belong in the beautiful open space of Ken-Caryl. Mullein, also known as Jacob's Staff, velvet, or flannel plant, was introduced to America in the mid-1700's because it was considered a medicinal herb and fish poison. The leaves have also been used as lamp wicks, toilet paper and a warm lining inside shoes.

In its first year, the mullein plant develops as a rosette with felt-like leaves which can grow as wide as 12 inches across. Then, in its second year, the plant bolts, producing a stalk with sulfur-yellow flowers, which can grow as tall as 6 feet and produce as many as 180,000 seeds. The tall, brown, candlestick-like stalks are the remnants of this plant. The only good thing about these spent stalks is that red-wing blackbirds, meadowlarks and bluebirds often use them as perches other than that, they are in stark contrast to the beautiful green grasses of the open space and are hosts to ticks.

Prevention is the best way to control mullein. The well-established grasses in the Ken-Caryl open spaces go a long way to prevent mullein's establishment, but it is important to detect infestations early, given how rapidly it spreads. Mullein

grows quickly in disturbed soil - along roadsides and trails - and then spreads to the surrounding open meadows and fields. Mullein has a deep taproot with an extensive secondary system of fibrous roots closer to the surface, which allows it to access soil moisture better than native plants, giving it a competitive advantage.

The Ken-Caryl Rangers spray herbicide each year, which is effective in combating the large infestations in highly visible areas, such as along the entrances and roadsides. Their annual budget, however, only allows so much spraying to be done each year. Also, herbicides can be harmful to a variety of pollinators. That is where the Weed Warriors come in - digging up plants in areas not sprayed, in the harderto-reach areas, and digging up plants missed by the spraying effort.

This is where you, as a homeowner and user of our beautiful open space, can help. Have you noticed this plant in your yard or in your garden? You too can become a Weed Warrior by eliminating the random plants that are on your own private property. By digging and disposing of the flower cones on your private property, you can help stop the spread of mullein in Open Space.

Here's what you do:

- Correctly identify the plant as mullein, either in its first year felt-like rosette form or in its second-year form as a larger rosette with a flower stalk.
- · If the stalk has begun to flower, clip off the flowering stalk and carefully place the stalk in a sturdy bag (without holes, so no seeds will escape), then dig up the plant. Leave the plant on the ground to decompose or remove the entire plant.
- Dispose of the flower stalks in a wellsealed bag in your garbage. Right now, it is easy to spot the large

plant with the flowering stalk, but be on alert for the smaller (first year) fuzzy rosettes that very often surround the larger plant. Dig out these rosettes and leave them to decompose or remove the

The Ken-Caryl Weed Warriors is a group of 18 volunteers that formed this spring with the support of the Ken-Caryl Rangers. As of mid-July, the Weed Warriors have dug out over 54,000 plants! The group goes out Tuesday, Thursday and Sunday mornings to work together in densely infested areas. Willow Springs also has a volunteer weed team which will create a healthy corridor of grasslands along with Ken-Caryl Valley. If you are

Mask Matters: Your Questions Answered

On July 16, Colorado Gov. Jared Polis announced an executive order requiring masks to be worn in indoor public places. The statewide order requires masks indoors whereas Jefferson County Public Health requires wearing a mask or face covering both indoors and outdoors. The outdoor requirement is only in situations where a distance of six (6) feet from individuals who are not members of their household cannot consistently be maintained. Below are answers to some frequently asked questions from the Colorado Department of Public Health and Environment.

Why did the state wait until July 16 to issue the mask order?

The governor and state public health officials know masks are one of the most effective tools we currently have to limit the spread of COVID-19, but orders are often best issued and enforced at the local level. While more than thirty-nine (39) Colorado cities and counties have mask orders, others do not. A statewide order helps eliminate confusion and makes mask requirements more consistent across the state.

The state also said that businesses have asked for a statewide rule to help eliminate confusion for people moving between communities.

What is considered an indoor public space?

For the mask order, "public indoor space" means a publicly or privately owned, managed or operated, enclosed indoor area that is accessible to the public, is a place of employment, or is an entity that provides services. Public indoor space does not mean a person's residence, including a room in a motel or hotel or a residential room for students at an educational facility.

This includes government buildings, transportation, grocery stores, hair salons, places of worship and more. A thorough list can be found on the state's website. https://covid19.colorado.gov/mask-guidance

Who does and does not need to wear a mask?

The order applies to people in Colorado over 10 years old when they are in a public indoor space or when they are waiting for or using public transportation or ride-shares.

People who cannot medically tolerate a face covering are not required to wear one. Many businesses have created options to assist people who cannot wear masks, but if you have questions you should contact the business directly.

What will happen if I refuse to wear a mask?

If you refuse to wear a mask as required in the executive order, you are violating a Colorado law and are subject to civil or criminal penalties. If you try to enter a store without a mask, you may be prosecuted for trespassing.

Is there a specific kind of mask I need to wear?

You should wear something that covers your nose and mouth — a cloth face covering or a disposable mask. The best mask for you is one you can wear comfortably and consistently. Any mask or face-covering that covers the nose and mouth will work.

The state continues to encourage residents to use cloth face coverings to preserve medical mask supplies for health care and other essential workers.

Why do I need to wear a mask if I'm social distancing?

It is becoming increasingly evident that masks are an inexpensive and easy way to limit disease spread. Together, masks and distancing offer a greater measure of protection. We strongly encourage all people in Colorado to practice the Big 3: Wear a mask. Wash your hands. Keep your distance

You and Your Family Need CodeRED

The CodeRED Emergency
Notification System is available
to all residents of Jefferson
County, including Ken-Caryl.
Notification during a wildfire
emergency can save lives. CodeRed
is used by law enforcement, fire
departments and Emergency Medical
Services (EMS) agencies to alert residents
of emergencies in their area, including
wildfire evacuation notices.

Many people do not realize that when they dial 911 on a landline phone, their location is displayed to the emergency dispatcher taking the call at the Public Safety Access Point (PSAP). This process is known as "reverse lookup" and allows a dispatcher to quickly determine the caller's location. The operator can also dispatch help to the address and proceed with emergency response even if the call is disconnected or the caller is unable to speak due to a medical emergency or threat.

But what happens if a caller uses a mobile phone? That's the problem affecting many people today. According to a 2012 report from the U.S. Centers for Disease Control and Prevention, more than 55 percent of American households with residents between the ages of 15 and 24 years old do not have a home phone. As more households choose mobile phones over landline phones, fewer people are receiving reverse 911 calls. Instead, they're opting for alternate contact method including mobile phones.

CodeRED allows citizens to enter various communication paths so they can be reached in emergencies. For the past few years, citizen opt-in portals have been popping up on various municipal websites, making it easy for people to add multiple contact methods, even while away from home. Meanwhile, the implementation of these systems corresponds with the rising demand for new and more personal ways of receiving communications.

The CodeRED Emergency Notification System is designed to quickly provide important information to local residents regarding critical incidents. Because the CodeRed Emergency system is designed to call landlines within the community, those residents and businesses currently without a landline telephone must register their contact information to be on the emergency notification list. The CodeRed registration website is available to register your contact information and

preferences from the Jefferson County Sheriff's Office Website: https://www. jeffco.us/473/Emergency-Notifications.

Registration is especially important for those addresses without a landline, as individuals must register if they want to receive emergency notifications.

The CodeRED system is used by emergency service agencies in Jefferson County to help disseminate important information regarding critical incidents.

How it Works

A CodeRED notification recording will let you know it's a message from the Sheriff's Office. CodeRED caller identification should display 'EMERGENCY COMM' and the phone number 866-419-5000 (text messages come from 76993, which you may program into your contacts list). CodeRED also works with a telecommunications device for the hearing impaired (TDD).

If the line is busy, CodeRED will keep calling back. CodeRED will attempt to leave a message. If you don't get a message, or would like to hear it again, call 866-419-5000 to receive the last message sent to your area.

The App

CodeRED also has an emergency notification app. Unlike the database, the CodeRED app will give you notifications when you are in geographic proximity to a warning area. For instance, you might visit a friend or family member who is within the warning area. The app will detect your proximity and provide you the same warning given to those who live and work in that area.

Opt-In

CodeRED reaches numbers from two databases. One is the 911 database, which contains all listed and unlisted land lines in Jefferson County. If you have a land line, it is automatically included in this database.

The second database is made up of Voice over Internet Protocol (VoIP) numbers (if you have a bundled internet / phone / television service you probably have a VoIP line), and email addresses owned by people who have opted in to receive the calls.

If you don't have a traditional land line phone, and would like to receive a text, email or cell phone call in addition to the call on your land line phone, consider registering for this free service. To register, visit the CodeRED phone registry.

Through the CodeRED cell registration you can add additional numbers and locations to your profile. For example, if you work in Jefferson County, you may want to add your work address to your profile so you receive notifications related to incidents in that area.

Oh, Rats!

Several residents have noticed rats outside their homes in both the Plains and the Valley. Although rats are a part of our natural ecosystem, they are not always viewed as welcome neighbors. Some residents have reported success with live rat traps when addressing rats around their homes, while others have used professional services or alternative strategies.

Jefferson County Department of Public Health (CDPHE) provides the following information for homeowners concerned about rats on their property:

Like many rodents and small mammals, it is possible for rats to carry diseases. However, rats do not generally pose a public health risk in Colorado, and at this time, there are no known diseases associated with the rat population in Jefferson County. Rats are more of a nuisance than a public health concern.

What Can You Do About Rats in Your or Your Neighbors' Homes?

If there is a rat infestation in your neighborhood, the most important thing you can do is control rats in and around your own property.

First, inspect all areas inside and outside of your home that might provide rats with a place to hide or build a nest, such as crawlspaces, sheds, woodpiles, undisturbed boats, RVs and vehicles. In addition to looking for rats, while you are inspecting:

- Look for any holes or openings in your home and/or outbuildings that are larger than the size of a nickel. If you see openings, seal them to prevent gnawing and access.
- Remove any food from pet dishes, pet waste or uncovered garbage.
- Pick fruits and vegetables from gardens and be sure to pick up any fruit from trees that may fall on the ground.

- Neighbors with animals allowed in your neighborhood should identify effective ways to keep feed and water away from rodents while still properly caring for your animals.
- Be sure to empty pet watering bowls and, if you see evidence of rats on your property, be sure to empty rainwater from any containers and drain ornamental ponds and fountains until the rat issues are resolved.

If you find signs of rats, use rat snap traps to quickly and humanely kill rats as they attempt to eat the bait. There are several advantages to using snap traps (as opposed to poisons):

- They provide a quick solution for trapping rats.
- Using traps will minimize the chances of decomposing rodent odors and fly problems.
- Most mechanical traps can be reused many times.
- They are nontoxic, which means they are less likely to harm children, the environment or other animals.

Although it takes patience and strategy, snap traps are an effective and a nontoxic method to eliminate a rodent infestation. However, it is important that rat traps are used safely to ensure that people particularly children, pets and non-target animals — do not accidentally encounter the traps. When placing traps indoors, place traps in darkened corners, along walls, or behind appliances and objects. Use similar techniques when placing traps in outdoor locations. If you trap rats yourself, be sure to use gloves and double bag any potential carcasses before placing them in the trash. Wash your hands thoroughly after handling a dead animal.

You may wish to hire a professional to install traps. But, ensure that you understand the principles for effective

trapping and don't assume that a pest control service will use these techniques unless you require it when you hire them.

Poison baits or rodenticides, which are pesticides that kill rodents, are not recommended because of the risk to children, pets, non-target animals (such as hawks or other birds of prey, coyotes or bobcats) and environmental concerns. Rodenticides can also harm pets or nontarget animals by "secondary poisoning," where the pet or animal preying on a poisoned rat is also poisoned. An example is when a cat, dog or bird of prey eats a rodent that is dying or has been killed by rodenticides.

Ban the Burn! Jeffco Stage 2 Fire Ban Restrictions in Effect

Please be advised that as of the printing of this paper, a Stage 2 Fire Ban for Jefferson County, as ordered by Jeffco Sheriff Jeff Shrader, is still in effect. This temporary Stage 2 Fire Ban supersedes all previous fire restrictions and bans and applies to all lands in Jefferson County.

This temporary ban was enacted due to the continuing high fire danger condition within Jefferson County. As a result, the following activities are prohibited pursuant to a Stage 2 Fire Ban:

- Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area of at least six feet in diameter that is barren or cleared of all combustible material.
- Building, maintaining, attending or using any fire.
- Recreational fires, including recreational campfires.
- Open burning including "bon fires" that require a permit from the fire authority having jurisdiction.
- The use of all fireworks.
 - Chainsaws shall only be operated with a USDA or SAE approved spark arresting device properly installed and in proper working order, and having an extinguishing source, water, pressurized water extinguisher, or a proper chemical pressurized extinguisher large enough to handle nearby hazards and possessing at least one large size pointed shovel with an overall length of at least thirty-six inches. All must be readily available for quick use.
- Welding and cutting torch appliances shall only be operated within an area that is barren or cleared of all combustible material at least 30 feet in all directions from the operating equipment. This operation may only be done during a declared "Fire Ban" upon receiving a permit from the Fire Authority having jurisdiction over the operating location.
- Use of an explosive initiation system requiring a burning fuse line.





Dear Editor:

To all the residents who are disappointed but not surprised that there will be no swimming at the Ranch House or Bradford this year, you may want to ask yourselves why the MD Board did not immediately make plans to open the Bradford Pool once it became clear that the RH pool would not be ready on July 15. The end of August is the new "anticipated" date for completion, but, to coin a phrase from technology projects, of which year I wonder? Here is the extract from the July 28 Board Packet:

"Ranch House Pool: The latest update from the contractor is very disappointing as he indicated the pool was again behind schedule and gave a new completion window of August 21 – 28. Staff feels the likelihood of the pool being operational during 2020 is unlikely."

If you take a look at the Board packet for the July 28 MD meeting, you will see that I had made a resident comment at the June 23 meeting suggesting that contingency plans should be made to switch staff between RH and Bradford in the event that RH would not be ready, but this suggestion was ignored.

Given that "swimming" is the top service valued by residents, after trail use, according to the surveys we complete, it would seem logical that the Board should be doing all it can to make as many pool hours as possible available to residents. And especially after it became clear in week one that demand for the Community Center Pool was such that restrictions on reservations had to be put in place.

Given the significant and unnecessary diminution in available swimming options this summer, I think that we, as residents, deserve to be told by the people we elected why it was decided to keep Bradford closed, even after it was clear the Ranch House would not be ready.




