While this meeting was the first opportunity to provide feedback on the 2021 budgets for both Boards, there's still time to voice your opinion either via email or at a future meeting.


While District Manager Traci Wieland will address the Metropolitan District's budget in a future issue, I will concentrate on the budget process for the Master

Association. The first draft of the Master Association's 2021 budget will be online no later than Sept. 15. This version will be a very preliminary draft. As part of the draft budget, I will include a running list of potential one-time projects for 2021. At the Sept. 15 Master Association Board meeting, the Board will review the list of projects and give me direction on which projects they would like to fund in 2021.

An updated draft budget will be posted online by Oct. 20, which is the Master Association Board's regularly scheduled business meeting. The budget is proposed to be adopted in October, but it can be pushed to November if the Board feels more discussion or changes are needed.

MD Board Summary

The Metropolitan District Board met for a regular Board meeting on Tuesday, Aug. 25. The following is a summary of that

- The Board heard a presentation from the District's auditor regarding the 2019 Audit. The Board later approved the 2019 Audit.
- The Board opened and closed a public hearing on the Proposed 2019 Supplemental Budget. The Board later approved a resolution adopting the 2019 Supplemental Budget.
- The Board received an update regarding the District's COVID-19 pandemic response and recovery. Staff informed the Board regarding a positive COVID case with a participant, monthly cash flow projections, and use of capital funds. The Board approved the use of Conservation Trust Funds for automatic doors to be installed at the tennis building.
- The Board approved the Third Amended and Restated Garden Club Use Agreement which extends the agreement until 2025.
- The Board heard a presentation on a recommended cost recovery philosophy for recreation, park and facility programs and fees. The philosophy will be used to help guide the development of fees schedule for 2021.
- The Board heard public comment from a resident regarding the Lilac Ash Borer and its impact on Ash trees on Ken-Caryl Ranch, as well as a resident who thanked the Board for its collaboration. The Board's next regular meeting will be held on Sept. 22.

Town Hall / MA & MD **Joint Study Session Meeting Summary**

On Tuesday, Sept. 1, the MA and MD Boards convened for their Budget Town Hall and Joint Study Session. Below is a summary of this meeting:

• Historical Society Chair Jim Antes gave an overview of activities of the Historical Society and requested a water supply line at the Bradford Perley House. Staff provided Jim an update on the cost of extending a water line to the Bradford Perley House. The cost would be approximately \$2,500 and could be accomplished this fall.

- · Rilla Reinsma discussed the importance of fencing and signage to preserve the South Hogback Open Space. She also wants to delay funding of a biological study for the South Docmann area. She also expressed support for a resident survey in 2021.
- Eric Mercer requested a regulation sand volleyball court in the community. He said about 40 residents have expressed interest in a volleyball court. Staff suggested asking for resident feedback via the next resident survey to gauge interest in courts.
- Jerry Sullivan requested a committee and funding for community perimeter fences. He also wants emphasis on medians. He is also concerned about streetlights and funding for electricity. He also doesn't like the fence color around the Ranch House. Scotty Martin mentioned the idea of doing an assessment on some of these topics.
- Kayla Kirkpatrick asked about previous task forces and committees.
- Staff provided an overview of the Community Collaboration Group, which is made up of two members of the Master Association Board, two members of the Metropolitan District Board, the Master Association Executive Director and the Metropolitan District Manager.
- Staff presented the idea of funding collaboration for Forestry/Parks Maintenance and provided a status on the state of urban forestry in Ken-Caryl Ranch. The Boards expressed support for funding collaboration and will discuss further at their respective Board meetings.
- Staff provided an update on insurance for the two entities. Staff is in the process of performing a full audit of insurance. The Boards will look at either a Cooperative Agreement or a 3rd Amendment to the Reorganization Agreement to clearly outline the insurance arrangement between the two
- Jerry Sullivan expressed concern about a homeless person sleeping in Settlement Park. Staff is aware and has spoken to the individual. He also expressed concern about crossings in the Plains.
- Jim Fodor expressed concern about tree replacement and wants more funding for trees. He thinks too much money is spent in open space and is concerned about liability in the open space and

Fall Weed Management

As the weather begins to turn cooler, the rangers are planning their fall weed management activities. The two most important seasons are in the spring, when plants begin their growth cycles and, in the fall, when they are shutting down and storing reserves for the winter. Weeds, like knapweed and musk thistle, are very susceptible to spring applications due to the uptake of chemical during their early growth stages. Fall weed spraying can be very effective since plants can transport herbicides to their roots along with water. Species targeted in the fall are deeply rooted perennials like Canada thistle, which require several management strategies to achieve control. The rangers have been busy this summer preparing spray areas for fall management.

Mowing is part of an integrated management approach to weed management. Noxious weeds have been known to develop a resistance to herbicides, so using different methods like prescribed burning, mowing and seasonal variations can give us a better chance of controlling

noxious weeds. During the summer months, the rangers mow infested areas of noxious weeds to limit seed production and to stimulate the weeds like Canada thistle to "flush out." This method encourages the plants to use more energy in creating more green foliage and provides a greater surface area for herbicide application. The mowed areas are less likely to survive the winter due to less stored energy and the herbicide applied to the plant surface is quickly transported to the roots where it can do more damage to the plant. Hardy perennial weeds easily survive "top kill" application due to their significant stores of energy below ground.

The ranger staff has been prioritizing fall spraying objectives throughout the summer based on the following: areas that were mowed, resident input and critical habitat areas. A target weed species list is generated by the state, which lists the most noxious weeds and under state mandate and requires property owners to control these weeds. The amount of control is dependent on each species with the goal of a reduction in numbers over time.

The ranger staff encourages residents near open space to monitor and manage weeds on their own properties and in the open space by their homes. Residents are allowed to mow a ten-foot buffer in open space, which can help in weed control. A resident can also use a broadleaf specific herbicide like Weed Be Gone, but residents should never use herbicides like Roundup because it kills all plants in the management area. Before treating weeds in open space,

the ranger staff asks that you contact our office and schedule a field visit so that we can evaluate the weed problem and make recommendations.

KCR Rangers and CPW Stepping Up Efforts to Keep Residents and Bears Safe

The KCRMA Rangers, in conjunction with Colorado Parks and Wildlife (CPW), will be ramping up efforts help educate homeowners to the dangers of potential bear conflicts due to residents not abiding by recommendations, rules and regulations to help keep the community and area wildlife safe.

Reports of bears entering open garages and rummaging through trash put out the evening prior to scheduled pick-ups has been encouraging bears to search for food within our neighborhoods. Bears are getting into freezers and destroying trash receptacles in search of food sources. This increases the likelihood of bear attacks, damage to property and harm to wildlife.

As a result, CPW and our own ranger staff will now conduct drive-throughs around the neighborhoods on several evenings and make note of any trash or recycling bins put out the night before and/or not secured properly, in addition to noting any open garage doors. CPW will contact that homeowner directly to address this issue.

KCRMA Rangers will also be conducting separate drive-throughs and will report any of the aforementioned issues directly to CPW for immediate follow-up. They will also be placing 'bear door hangers' at surrounding houses as reports come in regarding a bear directly locating a food source, trash cans and open garages at a property.

According to District Wildlife Manager Jerrie McKee, CPW will also be placing educational materials on the Nextdoor app and will consider listing neighborhoods or streets where issues have occurred to drive home the importance of taking the steps necessary to keep residents and bears safe.

As an added safety measure, KCRMA Ranger staff will also place 'Bear Aware' information in the open space kiosks.



Bear Necessities to Avoid Conflicts

Bears are now in hyperphagia, the period when bruins are preparing for hibernation and will spend up to 20 hours a day on the hunt for 20,000 or more daily calories. If attractions are not removed, bears will continue to linger in your neighborhood. Removing these attractants, and hazing bears when you see them, can help encourage bears to move out of your neighborhood on their own, reduce conflicts and keep you and the bears safe.

Here are helpful tips to prevent conflicts:

- Trash must be secured and locked up at all times. Only put trash curbside on the mornings of collection.
- All birdfeeders (seed, suet and hummingbird) must be removed until Thanksgiving.
- Close all garage doors, especially at night.
- Remove food, and any other scented items, from vehicles and lock the doors at night.
- Feed pets inside.
- Fruit trees attract bears; clean yards daily of fallen fruit and pick ripened fruit immediately.
- If you see a bear in your yard, haze it. Activate the car alarm, honk your horn, yell from a window, use an airhorn, etc.

Teach your children to be **SMART** if they have a close encounter with a bear:

- S Stop. Do not run!
- M Make yourself look big
- A Announce your presence in an authoritative voice "Leave me Alone!"
- \boldsymbol{R} Retreat by backing away slowly
- T Tell an adult about the encounter

Encourage your neighbors to do the same!

CrossFit Ken-Caryl Adds New Outdoor Workout Space

CrossFit Ken-Caryl moved its location to the corner of Ken-Caryl and Simms approximately one year ago, and business is thriving despite COVID-19, which is in part due to the construction of the gym's new, open air addition. According to owner and Ken-Caryl resident Chad Becker, the open air workout area provides a comfortable, safe and private area for clients to work out. He adds that the gym's new centralized location provides convenience for members, lots of parking and a bright, open space with lots of windows and a separate area of kids.

"With the move, we doubled the useable indoor square footage and obtained an additional 1,000 square feet of outdoor space," said Chad. "When COVID-19 and the statewide executive mask order hit, we felt that giving our members an option to work out outside in the open air would be a great decision. We quickly built out the outdoor space to include a privacy fence, outdoor flooring, awning shade, two lifting stations and five pull-up stations. This gives our members a good opportunity to get out in our great Colorado weather and have a comfortable workout."

According to new member Melina Felix, the new outdoor addition to the gym was a 'game changer' for her when joining CrossFit Ken Caryl.

"I left a gym that had zero outdoor space, so you couldn't work out without wearing a mask, something I find impossible," said Melina. "At CrossFit Ken Caryl, not only can I actually breathe during my workouts, but I also get my daily dose of vitamin C - a COVID deterrent - from the sunshine."

The gym has become a beloved member of the community, with patrons singing its praises, especially in how it adapted to still provide services to members during the height of the health pandemic.



"The gym's owners, Chad and Jamie Becker, have gone above and beyond during the pandemic," said member Emily Goff. "They provided daily Zoom workouts during the lockdown - workouts you could do with common items found at home and also allowed members to "check out" some of the equipment to use at home. When the gym was allowed to re-open, they followed all state protocols."

According to Goff, during the pandemic, the Beckers immediately went to work on the outdoor space, which provided a breezy and shaded area for about four to five members to safely work out without masks and still socially distance. Goff adds that the space also features an installed rig with several weight racks, pull up bars and mats out back where another two or three members can exercise without masks.

In addition to providing a safe outdoor space for members to work out, the Beckers have also taken great care in ensuring the safety of patrons inside the gym as well.

"The size of the [gym] space has become very important during the pandemic," adds Goff. "The floor is taped off into giant squares and you stay in your square to work out and to maintain physical distancing. Everyone in the gym wears a mask and we wash hands upon entering and leaving the gym through different doors. They also sanitize the equipment we use when we are done. All of this is very much appreciated to keep everyone safe and healthy."



Ken-Caryl Mom Finds Joy and Love to be Positive Medicine in her Battle Against Ovarian Cancer

When Ken-Caryl resident, Karen Kennedy, first heard she had ovarian cancer, her immediate reaction was shock and denial. She remembers grabbing a pillow and screaming into it as her daughters shared what the surgeons discovered during surgery for what Karen had thought was uterine fibroids.

Karen had recently returned from a trip to Africa during which several of her fellow travelers experienced intestinal disorders. When she experienced diarrhea, she went to urgent care and started on antibiotics. A few weeks later, she had pain in her right side and went to see her primary care physician who sent her for a CT scan, followed by a pelvic ultrasound. Karen, a nurse, self-diagnosed herself throughout the journey – first thinking she had a GI infection, then appendicitis and finally fibroids. Ovarian cancer never even crossed her mind until her daughters uttered the words.

Karen's daughters and friends rallied by her side throughout her treatment, which consisted of a full hysterectomy and six rounds of chemotherapy. Whenever she visited the hospital or infusion center, she went with a group. Her daughters and friends would string lights around the room, play music and create a festive environment for Karen and whomever happened to be receiving treatment at the same time. On her final day of chemotherapy, they hired an entertainer, The Singing Bee, who brought smiles to the faces of everyone in the infusion center. To celebrate the end of Karen's treatment, her daughters hosted a party and surprised her by inviting loved ones from across the country, creating shirts and pins to honor Karen's battle and putting out a donation box to "send Karen to the beach."

Their support and the moments of joy they created helped Karen keep a positive outlook. Karen learned a lot about the importance of love and joy throughout her battle with ovarian cancer. "It's so important to allow your loved ones to be part of your story and support you," says Karen.

She also feels it's important to create connections with other women who have had a similar experience. She joined Nicki's Circle; an ovarian cancer support group sponsored by the Colorado Ovarian Cancer Alliance. At first, she was concerned that hearing the problems and concerns of women battling the disease would be depressing, but found that the group quickly bonded. She explains, "These women have become my sisterhood. They get it. Our families sympathize, but these ladies know what it's like to battle the disease and the treatment." Karen also feels rewarded by knowing that she's helped inspire other women who are newly diagnosed.

September is National Ovarian Cancer Awareness Month and Karen encourages women to become familiar with the most common symptoms of ovarian cancer bloating that is persistent, eating less and feeling fuller, abdominal pain and trouble with urination and bowel habits. Looking back, Karen recalls feeling bloated and experiencing urinary urgency even before she left for her trip to Africa. However, since she was fit and healthy and the symptoms were subtle, it didn't occur to her that they might be signs of something serious, which is why she believes symptom education is so important. A woman who experiences any of the above symptoms that persist for more than two weeks should consult her physician. There is no screening test for ovarian cancer, which is the deadliest gynecologic cancer, so symptom recognition is critical for early diagnosis.

Founded in 2005, the mission of the nonprofit Colorado Ovarian Cancer Alliance is to provide support to those affected by ovarian cancer, and to promote awareness and early detection of ovarian cancer through advocacy and education. Programs include COCACares Financial Assistance, Nicki's Circle Support Groups, the Ovarian Cancer Resource Guide, Comfort Kits for the newly diagnosed, Carol's Wish Financial Assistance Program, an annual Raise Awareness campaign, and Survivors Teaching Students: Saving Women's Lives, a national program of the Ovarian Cancer Research Alliance (OCRA).

Did you know that September is National Ovarian Cancer Awareness Month?

All women are at risk for developing ovarian cancer, which is one of the deadliest forms of gynecologic cancer. In the United States alone, the condition is diagnosed annually in nearly 21,000 females and responsible for causing approximately 14,000 deaths.

In recognition of these facts, former President Barack Obama declared the month of September as National Ovarian Cancer Awareness Month. The goal is to raise public awareness about the condition's early warning signs and ultimately save lives.
