Adding on to Your Home

Thus far during the year we have processed submittals for additions to existing homes. I am sure there are a variety of reasons for adding on to your home, but I like to think it is partly because folks love living on Ken-Caryl Ranch and want to stay here.

The primary goal of the Architectural Committee as they review additions is to have the new construction look like it has always been there. To have the addition match the rest of the home is most important. The major requirements for additions are submittal of: Site and grading plans showing the house and location of the addition (also setbacks), exterior elevations, an engineered foundation plan and samples of the exterior materials being used. Should you be contemplating an addition to your home, you are welcome to meet with our Architectural Consultant for a feasibility review.

For those of you who may be new to our community, we want to welcome you and provide all the information to you in the simplest and most convenient manner. Trash and Recycling Information

Waste Connections is the trash and recycling service provider for Ken-Caryl Ranch. Service is included as part of the Ken-Caryl Ranch Master Association monthly dues. Waste Connections can be reached at 303-288-2100 or www. wcdenver.com.

Trash and Recycling Totes: Residents have the option of using their own trash and recycling containers/bags or using 96-gallon totes provided at no charge by Waste Connections. The totes have wheels and are 42 inches tall, the top measures 30x34 inches, and the bottom is 24x24 inches. To order totes, send an email to kencarylco@wasteconnections.com, say that you want to sign up for totes, and provide your name, address, email address, and phone number. You can request both trash and recycling totes, just a trash tote, or just a recycling tote.

Holiday Trash Delays: Waste Connections observes the following holidays: New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas Day, unless they fall on a weekend. If your normal pickup day falls on or after a holiday, your collection schedule will run one day late that week.

Auto-Dial Service: Waste Connections offers an auto-dial service called Call Fire to notify customers of any changes in trash pickup days. You can sign up to receive a phone call online at www.wcdenver. com/contact/. Complete the required information, click on Residential Trash Service, then in the comment section say you are a Ken-Caryl resident seeking to sign up for the Call Fire service.




Hazardous Trails Near Brannon Gearhart Park and Wood Sorrel/Buckthorn Access Trail - Open House to Discuss Proposed Improvements

The Ken-Caryl Ranch Master Association Board is considering a proposal to reroute sections of hard-surface trail and rebuild low-water stream crossings in and around Brannon Gearhart Park and is seeking community input on the project. An open house is being held on Sept. 27 from 6 to 8 p.m. at Dakota Lodge where residents can learn more detail about the project.

The trail re-routes will take out steep sections of trail (see map) and move the alignment out of shaded areas to improve trail user safety during the winter months. The low-water crossings will be rebuilt to better facilitate emergency and maintenance access and improve user safety.

The project will be funded from the Ken-Caryl Ranch Master Association annual budget and reserves using money allocated for drainage repairs and conversion of asphalt trails to concrete paving.

Board Meeting Summary

Joint Study Session

On Sept. 6, the Ken-Caryl Ranch Master Association and Metropolitan District Boards held a Joint Study Session at the Ranch House and discussed the following items:

- The Boards received 2017 Budget requests from residents.
- The 2016 use statistics for the Bradford Pool were presented by staff and discussed as they relate to concerns expressed by a resident in a letter. Staff and Boards will continue reviewing for possible changes for the 2017 swimming season.
- A request to install bathroom opportunities in all parks was considered. Further consideration will be given this request by the Boards.
- A request to provide funds for seeding as part of the irrigation reduction plan was considered. The Boards asked the Parks Advisory Committee to refine their plan and come back to the Boards.
- Board representatives and staff updated with information learned in a meeting about the proposed section of the golf course rezoning. The County has ruled that the land is eligible for rezoning. A viable candidate to hold the conservation easement is being sought.
- Projects. The facilities are essentially completed with landscaping at the Community Center the largest part of the project remaining. Staff also updated the Boards on the park projects at Saddlewood and Heirloom Park. Saddlewood Park is completed and has been reopened with Heirloom Park planned to reopen by the middle of September.
- Residents commented on the changes to the Dakota Lodge campus, the North Ranch Pool use, survey results, a need for more restroom facilities in the parks, the Jefferson Corporate Center proposed apartment development, support for water conservation/use reduction and opposition to using the Deerwood Vista entrance island as a demonstration of what medians could look like if the landscape were to be updated.

Living With Bears on Ken-Caryl Ranch

Bear sightings on Ken-Caryl Ranch are common, both in the open space and in the neighborhoods. Encountering bears should be expected any time of the year, but they are definitely more conspicuous in the spring, late-summer and fall. Being large animals, they eat a lot. They eat just about anything, which is why the potential for a bear to visit your property is pretty good if you are inadvertently attracting them with food sources.

In order to avoid conflicts with bears (and other wildlife for that matter) remove all attractants from your property; in the case of bears this is mostly food items, i.e. dog food on the porch, trash left out on the curb overnight, birdfeeders, fruit trees, etc.

The following information, provided by the Colorado Division of Wildlife, provides good information on how to keep bears off your property and what to do if you come in contact with a bear. Remember: Every situation is different with respect to the bear, the terrain, the people and their activity.

Enjoy the woods! Hiking at dawn or dusk may increase your chances of meeting a bear. Use extra caution in places where hearing or visibility is limited: in brushy areas, near streams, where trails round a bend or on windy days. Avoid berry patches in fall. Reduce your chances of surprising a bear by making noise—talk or sing.

Make sure children are close to you or at least within your sight at all times. Leave your dog at home or have it on a leash.

Stay calm. If you see a bear and it hasn't seen you, calmly leave the area. As you move away, talk aloud to let the bear discover your presence.

Stop. Back away slowly while facing the bear. Avoid direct eye contact as bears may perceive this as a threat. Give the bear plenty of room to escape. Wild bears rarely attack people unless they feel threatened or provoked.

If on a trail, step off the trail on the downhill side and slowly leave the area. Don't run or make any sudden movements. Running is likely to prompt the bear to give chase, and you can't outrun a bear. Do not attempt climbing trees to escape black bears. This may stimulate the bear to follow and pull you out by the foot. Stand your ground.

Speak softly. This may reassure the bear that no harm is meant to it. Try not to show

Be Cautious With Cubs. In contrast to grizzly bears, female black bears do not normally defend their cubs aggressively; but send them up trees. However, use extra caution if you encounter a female black bear with cubs. Move away from the cub; be on the lookout for other cubs.

Bears Have Great Senses. Bears use all their senses to try to identify what you are. Remember: Their eyesight is good and their sense of smell is acute. If a bear stands upright or moves closer, it may be trying to detect smells in the air. This isn't a sign of aggression. Once it identifies you, it may leave the area or try to intimidate you by charging to within a few feet before it withdraws.

Fight back if a black bear attacks you. Black bears have been driven away when people have fought back with rocks, sticks, binoculars and even their bare hands. Black bears vary in size and weight, with males generally being larger than females. Adult males average 275 pounds, while the adult female may average 175 pounds. Depending on the season, food supply and gender, they may weigh anywhere from 125 to 450 pounds. Black bears measure about three feet high when on all four feet or about five feet tall standing upright.

What to Do if You Live in Bear Country

If you choose to live or have a summer home in bear country, make sure you don't contribute to resident bears becoming 'garbage' bears. Most conflicts between bears and people are linked to careless handling of food or garbage. Don't let your carelessness cause the unnecessary death of a bear. Learn to live responsibly with wildlife!

Black bears eat almost anything. They will eat human food, garbage, hummingbird food, and pet and livestock food when available. Once a bear has found the easily accessible, consistent food source that human settlements can offer, it may overcome its wariness of people and visit regularly, increasing the chance of a human/bear encounter. You and your neighbors can make a difference. Your actions may prevent the unnecessary death of a bear!

Make your property safe by keeping garbage out of reach and smell of bears. Use bear-proof trash containers. Be sure garbage cans are emptied regularly. Periodically clean garbage cans to reduce residual odor—using hot water and chlorine bleach, or by burning trash residue in cans. Store trash in a bear-proof enclosure. Contact Colorado Parks and Wildlife for designs.

If you have pets, do not store their food or feed them outside. Clean your BBQ grill of grease and store inside. Hang birdseed, suet and hummingbird feeders on a wire between trees instead of on your deck or porch. Bring all birdfeeders in at night. Do not put fruit, melon rinds or other tasty items in mulch or compost piles.



New School Year Can Mean Increase in Child Abuse & Neglect Reports; **CASA Volunteers Needed**

Summer break is winding down, and the back-to-school season is in full swing. The start of the school year can be a new and exciting time for children, but it can also lead to more reports of abuse and neglect as faculty, staff and other parents notice signs of maltreatment children may have suffered during the break.

Schools were the most common source of the more than 22,596 reports of child abuse or neglect that were received by the Department of Children, Youth and Families (DCYF) last year. DCYF completed 5,681 investigations as a result of reports from school officials.

"In the summer, children interact with fewer adults outside of their families who would see and report signs of abuse or neglect," said Leah Varnell, executive director of CASA Jeffco/Gilpin. "However, teachers and school officials are mandated reporters, so it is not unusual for there to be a spike in reports when school resumes."

The increase in reports often leads to more children entering the overburdened child welfare system, creating a need for more CASA (Court Appointed Special Advocate) volunteers to speak up for these children.

CASA volunteers are everyday members of the community that are specially trained and appointed by judges to advocate for children's best interests in court. These volunteers are appointed to one child or sibling group, and speak to any and all relevant contacts in their lives, such as teachers, foster parents and therapists.

"Imagine how frightening it is for these kids to be taken out of their homes and placed in foster care, sometimes far away from their families and friends," said Leah. "Our dedicated volunteers at CASA Jeffco/Gilpin work tirelessly to ensure that they do not get lost in the system and that their voices are heard."

CASA volunteers get to know these children individually and gather information about their unique physical, emotional and educational needs. They relay their recommendations to the court in an effort to help these children move out of the temporary system and into safe, permanent homes as quickly as possible.

In Jefferson and Gilpin counties, there are more than 1,000 children in the child welfare system. CASA Jeffco/Gilpin served 400 children last year. That means that there are still many children without a CASA volunteer to advocate for their needs.

"CASA Jeffco/Gilpin needs more compassionate, dedicated volunteers to speak up for these vulnerable children," said Leah. "As we start the new school year, consider being a voice for children in need by becoming a CASA volunteer."

The Jefferson County Sheriff's Office will join law enforcement agencies nationwide to remove potentially dangerous controlled substances from our nation's medicine cabinets. The next Drug Take-Back Day is Saturday, Oct. 22 from 10 a.m. to 2 p.m. The Sheriff's Office will accommodate collections at three sites in the county:

Sheriff's Office Headquarters (200 Jefferson County Parkway, Golden, CO) Conifer High School (10441 Co. Rd. 73, Conifer, CO)

Dakota Ridge High School (13399 W. Coal Mine Ave., Littleton, CO)

The Drug Take-Back Day provides an opportunity for the public to surrender expired, unwanted or unused pharmaceutical controlled substances and other medications for destruction. These drugs are a potential source of supply for illegal use and an unacceptable risk to public health and safety. This one-day effort is intended to bring national focus to the issue of increasing pharmaceutical controlled substance abuse.

- The program is anonymous.
- Prescription and over-the-counter solid dosage medications (tablets and capsules) are accepted.
- Intravenous solutions, injectables, needles and oxygen containers will not be accepted.
- Illicit substances such as marijuana or methamphetamine are not a part of this initiative.
- The prescriptions should be removed from the original containers and placed in a plastic bag prior to drop off.



Firefighters in the Wildland Urban Interface: Facing Risks in Protecting Your Family and Home

Wildland fires continue to increase in the Western United States as hot, dry and windy conditions persist, resulting in an extended fire season and conditions conducive to fires. When wildfires occur in the Wildland Urban Interface (WUI), the area where houses meet undeveloped land, they can easily become catastrophic because a large number of people, homes and structures are at risk.

When a fire ignites in these areas, a quick and aggressive response from fire departments, wildland fire agencies and many other resources is required. The firefighters from West Metro Fire Rescue who respond to wildfires within Ken-Caryl face significant health and safety risks. In addition, the deputies of the Jefferson County Sheriff's Office are at risk as they move into threatened areas to assist residents in evacuations.

Wildland firefighting can be a dangerous occupation. Over the past 10 years, more than 200 firefighters have died while participating in wildland fire suppression activities. These fatalities have occurred among federal, state and local firefighters as well as private and military personnel.

Hazards that wildland firefighters may encounter include:

Heat Stress

Firefighters working in hot weather may experience heat stress. Heat stress can progress into heat strain (physiologic changes such as increased core body temperature and heart rate) and, without appropriate intervention, can progress into heat-related illnesses (heat rash, cramps, exhaustion or heat stroke).

Fatiaue

Firefighters can also experience physical and mental fatigue during a wildland fire due to strenuous work activity, high altitudes, long and irregular work shifts, lack of sleep, improper nutrition, and unpredictable and stressful events. Fatigue and stress can increase the risk of injury, accidents and poor health.

Injuries

Wildland firefighters are also exposed to a variety of hazards that may put them at risk of both fatal and non-fatal injuries while on the job. Hazards wildland firefighters may encounter include:

- Slips, trips and falls
- Burns
- Scrapes and cuts from tools and equipment, such as chainsaws



- Struck by partially burned trees (snags) falling in wooded areas
- Contact with plants such as poison ivy
- Injuries sustained in crashes of vehicles/ airplanes/helicopters
- Electrocution from downed power lines and lightning storms
- Unstable building structures
- Exposure to venomous snakes in the open space

Respiratory Hazards from Smoke, Ash and Debris

Smoke and dust from a wildfire can be composed of a variety of inhalation health hazards, including gases, such as carbon monoxide, sulfur dioxide and formaldehyde, and particulates, including ash and silica. Structural fires that occur during a wildland fire may generate additional hazardous contaminants from the many materials present in homes and buildings. For example, car batteries or mercury lightbulbs present in homes and buildings have a greater potential to contain asbestos and lead. Firefighters cannot wear the breathing apparatus worn in structural fires due to weight issues.

Cardiac Events

Wildland firefighting is physically demanding, placing firefighters at risk for heart attacks, strokes and other cardiacrelated events while fighting wildfires.

Methods wildland firefighters use to reduce risks include:

LCES (Pronounced Laces)

Lookouts, Communications, Escape routes and Safety zones (LCES) must be established and maintained on every wildfire. Rapid, unexpected changes in fire behavior during all phases of fire operations can kill wildland firefighters.

Safety Equipment

Firefighters must always carry appropriate health and safety equipment, including a fire shelter. Training is critical so crews know when to properly use the safety equipment.

Awareness of Trees & Terrain

Firefighters exercise extreme caution when working in timber canopy areas and around power lines. Every tree has some level of hazard associated with it. Even

fine fuels, such as the grasses in Ken-Caryl Open Space pose risks; many fatalities and entrapments have occurred in areas of fine and sparse fuels where terrain and wind produce unexpected, extreme fire behavior.

Wildland firefighting can be a dangerous occupation. These men and women place themselves in harm's way to protect the lives and property of those living in the affected areas. Wildland firefighters must constantly assess the potential risks versus benefits in attacking a fire or protecting your home. Residents of Ken-Caryl can reduce firefighter risks by preparing for and safely evacuating in the event of wildfire.

Dear Editor:

I would like to add a few comments to Sean Warren's article on rattlers. I have made several trips this year up to the top of the Lost Canyon Trail and the Manor House Trail. For snake safety, the Manor House Trail is better -- the trail is wider and you can see the foliage on either side -- not as likely to be surprised by a rattlesnake. The drawback is that it's straight up, no switchbacks

I encountered a rattler on Lost Canyon about 1/3 up the trail. He was hunting so he had camouflaged himself very effectively in old leaf branches and shadows. I did not see him at all until he rattled. It startled me. I backed up several feet, waited and after several minutes he crawled off into the bushes. Rattlesnakes are not aggressive. Give them space, wait a few minutes and they will usually uncoil and slink off.

Cell phones do not work on the upper trails. My experience was to lose reception about half-way up both of these trails. Do not depend on them for help until you are further down. Avoid the narrower trails with vegetation growing close by.

Dear Editor:
In response to questions regarding
Dakota Lodge and the KCR Metro District
youth programs, I'd like to review some
standard operations of KCRMD to clarify
how Dakota Lodge is being utilized.
KCRMD youth programs are open to both
residents and non-residents (who pay
higher rates and fees) as we are a public
entity and our programming must be
made available for anyone to utilize. The
typical resident/non-resident ratio for our
programs is approximately 70/30.

Most youth programs are held at the Ranch House or Community Center, but Dakota Lodge has been "home base" for the Environmental Education classes. Upon Ranger Ernie's retirement two years ago, our new Environmental Educator, Gabrielle Chisholm, incorporated Ernie's programs and added new elements that have proven to be extremely popular. Most of our youth programs have grown in options and size to meet demand. We have had waitlists for summer camp the last seven years, and the Before & After School program is full at the Community Center.

When the planning for Dakota Lodge began and resident committees were called upon to help staff and architects to best utilize the building's function, the Environmental Classroom was called out as there was a need for more space to accommodate growing programs. It was also important to retain the community function of Dakota Lodge for meetings and events. The building can now be utilized better and serve more residents.

KCRMD has a licensing specialist who helps ensure our programs and facilities meet state guidelines. When our specialist visited last spring to inspect the remodeled facilities, she said Dakota Lodge was not holding the correct licensing for childcare

ages 5-12 years. This was immediately remedied for compliance. The 5-12 license is not to be confused with a preschool license, which we hold for the Ranch House and Community Center.

The staff works hard to provide programming to meet the demands of residents, and it should be commended for utilizing every available square foot to meet this need. KCRMD has never gone to residents asking for input to grow programming; the programming is determined by success and demand.

This was the survey issue that was of highest importance to the residents, so you need to understand that when our Boards make decisions to encourage dryland "native grasses" to replace existing irrigated turf, cut off irrigation to mature trees in our parkways, turn off irrigation systems to experiment with "turf reduction" and reduce irrigated areas in our parks by adding mulch beds, that we as residents do not feel like we are being heard and we feel misled.

The same can be said about the childcare centers at the Ranch House, Community Center and now, Dakota

Lodge. Child care of all types received the lowest level of interest from residents in the survey. Yet we have spent so much of OUR bond money to make all three of these facilities work as childcare centers with appropriate transportation and playground access. At the same time, plans to eliminate areas of irrigation and maintenance for our landscaping are being actively pursued when a beautiful community is a top priority for the residents. Our goal to get back to attractive, maintained landscaping is not happening. We do not look forward to being in constant disagreement with the Boards, rather we want to feel like our voices matter and the issues that we told you were important to us are being looked after.


