Colorado Supreme Court Rules In Favor Of KCRMD In Plains Metro District Case

On Dec. 23, 2013, the Colorado Supreme Court issued its ruling in the appeal by Plains Metropolitan District (PMD) of the May 2013decision from the Colorado Court of Appeals in favor of the Ken-Caryl Ranch Metropolitan District (KCRMD). The Colorado Supreme Court denied the PMD's Petition for Writ of Certiorari essentially affirming the May 2013

It's been a privilege to serve with the Master Association and Metro District Board members, six of whose terms end in March or May of this year. In my opinion, these two Boards have developed a great synergistic relationship, working together toward common goals. While full agreement can't always be expected, it is certainly healthiest for the community as a whole when the Boards are free to openly discuss their viewpoints and reasoning and to move forward with major decisions knowing that full vetting by both Boards has occurred.

Thanks to MD Board President Bob Generoli and all MA and MD Board members for making this happen, and to the MA Executive Director and the MD District Manager and their staff for following

through to achieve many goals this past year. Having the November 2012 survey results as a guide has definitely helped us to better represent the community.

Of immediate interest, both Boards are aligned in agreement that well-planned and managed investment is needed and is wise during this period of low interest rates to bring KCR assets and amenities back up to the strong functional and design standards that KCR originally represented. A possible municipal bond issue by the MD has been described in previous issues of Life at Ken-Caryl and will be discussed frequently in future Joint Study Sessions, Board meetings and Community Planning Committee meetings

The recommendation for a meaningful investment stems from the November 2012 survey results and the subsequent analysis and research by the KC2020 Task Force and then the Community Planning Committee. - Delayed Trash Days: Waste Connections observes the following holidays: New Year's Day, Memorial Day, July 4, Labor Day, Thanksgiving Day and Christmas Day, unless they fall on a weekend day. If your normal pick-up day falls on a holiday or after a holiday, your collection schedule will run one day late that

- The Boards and Community Planning Committee discussed a possible May 2014 Bond Issue Election with representatives of George K. Baum.





PLAN Jeffco continues its open space advocacy into the present.

The Jeffco LWV has been working to document the League's actions that forged Jefferson County's open space funding and policy. Results of the Jefferson County League of Women Voters Open Space Legacy Project will be reviewed at unit meetings this month. Round-one applications are prioritized through a lottery process. Parents and guardians must complete an application and send it to their school of choice. If a student is not accepted at a school during the first-round choice enrollment, the student will remain on the prioritized waitlist and be carried over to second-round choice enrollment, which is Feb. 19 through Aug. 29. route design since 2010 when the Colorado Natural Heritage Program was hired to complete a biological survey of the proposed trail corridor. The survey identified an array of sensitive natural resources in the area and as a result, significant alterations were made to the original re-route design. Staff believes the final design (see map below) will protect these sensitive resources, create a trail that is easier to maintain and safer to use.


Unlike the majority of Ken-Caryl Ranch Open Space, which is owned by the Ken-Caryl Ranch Master Association and is private, the South Hogback Open Space is own-

ed by the Ken-Caryl Ranch Metropolitan District (District) and is open to the general public. As the owner, the District Board has authority over management of the area. Recently, the District Board adopted the Ken-Caryl Ranch Trails Implementation Process and Strategy (KCRTIPS), a document initially developed by the Association Board, which in part lays out a process for approving new trail projects in Open Space.

The KCRTIPS states "... As part of the annual budget preparation process. Open Space staff with involvement of the Open Space Committee, will review the trail system and

develop an Annual Trails Report that identifies trail projects that require Board approval and recommendations for specific work projects for the upcoming year...". The 2014 Annual Trails Report was presented to the Association Board at their monthly business meeting on Dec. 17, 2013.





North America. The original idea of using snowshoes probably came from watching animals like snowshoe hares and lynx move across the snow.

The snowshoe was a reliable means of winter transportation allowing arctic tribesmen, people from Labrador to the Great Plains, to hunt, trap and forage. During the westward expansion, traders, hunters, explorers and surveyors all depended on snowshoes.


The first snowshoes were made of bent wood and animal skins and reached lengths of seven feet. By the end of the 19th century, most snowshoe styles were about three feet long. The wooden and hide material snowshoe remained the proven style until the

1970s when metal alloy frames and neoprene fabric decks were introduced. By the late 1980s recreational use of snowshoes took off. With the new lightweight shoes, which are easy to maneuver, a general desire for aerobic activity, and a desire to have low-impact outdoor activities that the whole family can enjoy, snowshoeing has become one of the fastest growing outdoor winter sports.

• If you believe someone may be using your Social Security number or you receive a letter indicating a problem, contact the IRS immediately at 1-800-829-1040 and file Form 14039: Identity Theft Affidavit.

- File a report with your local police department and save the report.
- Be vigilant about guarding your Social Security number. If your Social Security number is on an older Colorado driver's license, go to the Department of Motor Vehicles and get a new driver's license. If your Military ID card has not been replaced with a new number and still has your Social Security number, then only carry that card on an as needed basis. If you have a Medicare card, make a photo copy of the original and then put the original card in a secure place. On the photocopy, blacken the first five numbers and carry that copy in your purse or wallet. On a job application, in the right-hand corner where it asks for your Social Security number, place the response: "Will provide upon
- If anyone asks for your Social Security number, ask them if there is a legal requirement requiring it. Never provide it via an email or phone request.
- Remember that any business extending credit to you will require your Social Security number to check your credit history.
- Guard your tax returns; don't leave them in your car or on a copy machine. Don't carry copies around with you.



KCR Residents Can Now Use Ridge Recreation Center At Foothills Resident Rates

The Boards of Directors of both the Ken-Caryl Ranch Metropolitan District (KCRMD) and the Foothills Park & Recreation District (Foothills) reached a special arrangement for residents of Ken-Caryl Ranch (KCR) to use the Foothills Ridge Recreation Center at Foothills resident rates.

The Ridge Recreation Center, which is located at 6613 South Ward St. just north of the boundary of KCR, is owned and operated by Foothills, a local park and recreation provider. Residents of KCR have always been able to use Foothills facilities as they are all open to the public. However, in the past, residents of KCR have been assessed non-resident fees for Foothills facilities as it is a separate park and recreation district. Residents of KCR do not pay property taxes to help support the facilities owned and managed by

In November, KCRMD and Foothills entered into an Intergovernmental Agreement to permit KCR residents to use the drop-in amenities of the Ridge Recreation Center at the same daily rates as Foothills residents from Jan. 2 through Dec. 31. This agreement was reached on a one-year trial period, which

will be evaluated to assure that each organization is benefiting from the arrangement. The fee differential will be absorbed by the KCRMD and the Ken-Caryl Ranch Master Association.

an indoor lap and separate leisure activity pool, a therapy pool, a gymnasium and track, a cardio weight room, racquetball courts and a rock-climbing wall. As part of the agreement, KCR residents will receive a special ID card issued by Foothills, which will identify

the user as a resident of KCR. ID cards cost \$5 per card charged to the user and are issued by Foothills at the Ridge Recreation Center.

The current agreement is exclusive to the Ridge Recreation Center only. The agreement does not include the special discounted fee toward use of the Edge Ice Arena, the Peak Community and Wellness Center or any other Foothills amenities. The special rate is only for the drop-in use of these amenities and does not apply to classes or youth programs.

The KCRMD Board of Directors began working on this agreement with the Foothills Board early in 2013 following results of the 2012 KCR resident survey, which showed a strong interest in the ability to use an indoor, year-round swimming pool. 

Celebrating 100 Years______ Joseph Minissale, Ken-Caryl Real Estate Tycoon



Joseph Minissale owned Ken-Caryl Ranch from 1944 to 1949.

The story of Joseph Nunzio Minissale, who owned Ken-Caryl Ranch from 1944 to 1949, is a true rags-to-riches tale. He was born in Sicily in 1895 and immigrated to the United States in 1909, joining his father in Philadelphia. In Italy he was a laborer in a quarry and for stone masons.

In Philadelphia, he worked as a pipefitter and tried his hand at real estate, selling his first property at the age of 17. During World War I, he served in the Army for one year. He married Annunziata "Nancy" Piccione in 1920. Together, Joseph and Nancy operated a dress shop in Philadelphia before moving to Colorado.

In 1942, Joseph purchased the old Tammen Mansion at 1061 Humboldt Street in Denver, and in 1944 he bought the 10,000acre Ken-Caryl Ranch for \$250,000. Cattle, turkeys and wheat were raised on Ken-Caryl Ranch and two other ranches he bought around the same time. Minissale sold Ken-Caryl in 1949 to Cap McDannald for more than \$350,000. Around this time, he sold the Humboldt Mansion and purchased the former home of Verner Z. Reed at 475 Circle Drive in Denver, where he lived for the next 30 years. The Minissale family only visited Ken-Caryl Ranch because their permanent residence was in Denver.

Joseph made his fortune in real estate and reputedly was the first broker in Colorado to make \$100,000 in commission in a sale of land near Burlington, Colo. He sold his real estate firm in 1977, as well as his Circle Drive home after the death of his wife. Joseph died in Denver in 1990 at the age of







Have You Ever Hesitated To Call The Sheriff's Office?

It is a shame that some people are reluctant to report suspicious activity in their neighborhood. Perhaps they think that what they see is not serious enough to report or believe they would be deterring a deputy from other law enforcement duties.

While this may be true, it is disheartening to hear citizens say they should only call when they see an actual crime in progress so as not to waste finite police resources on something less than a real crime. What the average citizen may not know is that simple suspicious activity reports can save valuable investigative resources and time spent in solving the crimes.

A few weeks ago, a resident awoke to find her personal belongings strewn in the front yard. Apparently, her car had been trespassed and the glove box and console disheveled. She didn't notice anything missing so she reasoned that it wasn't necessary to report. It wasn't until she learned that five other neighbors had been victims that she called the Sheriff's Office. Ultimately, the suspect was charged with First Degree Trespass to Motor Vehicles due in part to her providing specific details about the incident.

Oftentimes, a deputy is dispatched to check on suspicious activity and will discover that the person in question actually is wanted on an outstanding arrest warrant. In such a case, the person is arrested immediately.

Prompt And Detailed Reporting

Prompt and detailed reporting of suspicious activities can help prevent crimes. If you see suspicious activity, please report it so local law enforcement officers can respond quickly. When reporting suspicious activity, it is helpful to give the most accurate information possible, including:

- Brief description of the activity
- Date, time and location of the activity • Physical identifiers of anyone you observed
- Descriptions of vehicles
- Information about where people involved in suspicious activities may have gone
- Your name and contact information (op-

All Jefferson County residents should know there are two different phone numbers with two distinct functions for the Sheriff's Office. Contact the Jefferson County Sheriff's Office at 303-277-0211 to report suspicious activity that is not in progress. If there is a life-threatening emergency or the activity is ongoing, please call 911. Simply put, an emergency is any situation that requires immediate assistance from the police, fire department or ambulance.

Important: If you're not sure whether the situation is a true emergency, we recommend calling 911 and letting the call-taker determine whether you need emergency help.

Report A Crime Online

In Jefferson County, you cannot access 911 help via text message or email, although new technology and regulations are anticipated that will make this possible in the future. In the meantime in an emergency, dial 911 from a regular or wireless phone to access emergency help.

In the circumstance that a crime is committed in unincorporated Jefferson County that is not an emergency or traffic accident, did not involve a weapon, and there are no known suspects, you may report this incident online. Some examples of appropriate online reporting incident types include: harassing phone calls, lost property, car breakins, theft and vandalism. The Sheriff's Office offers an address wizard tool to determine if the address in question is in unincorporated Jefferson County, a list of other area police departments, and finally, the File a Crime Online site all linked from jeffco.us/sheriff. All Ken-Caryl Ranch addresses are in unincorporated Jefferson County.


