MD Board Considers Community Improvements; Community Meetings Will Be Held In February To Discuss With Residents

The results of the 2012 KC2020 Resident Survey have been thoroughly analyzed, and you have asked for improved facilities and amenities such as upgrades to the Ranch House building and outdoor common areas; improvements to the Community Center campus and facility; Dakota Lodge renovations; improved water management, irrigation systems, and landscaping throughout the Ranch; and better pool areas, parks, playgrounds, and entrance signs.

As a result of direction gathered from the survey results and additional research, the Community Planning Committee has recommended to the Metropolitan District (MD) Board of Directors, and the Master Association (MA) Board of Directors that the best approach for funding these proposed investments in Ken-Caryl Ranch is to accelerate the improvements by using low-cost funds through the issuance of general obligation bonds by the MD. These bonds would be tax-free, municipal bonds issued to finance improvements to the facilities and infrastructure of Ken-Caryl Ranch.

In order to issue debt, the MD must receive the approval of voters in a proposed bond issue election scheduled for May 6. Should the residents of Ken-Caryl Ranch approve the issuance of bonds in May, the MD would be empowered to issue bonds and begin planning for the sale of bonds to cover the cost of the improvements.

Manager's Column_

As we move into 2014, the Metropolitan District Board of Directors continues to study the possible inclusion of a bond question on the May 6 ballot for the District Board of Directors election. During the past year and a half, the Community Planning Committee (CPC) has been analyzing the results of the 2012 Resident Survey, which was mailed to every home on Ken-Caryl Ranch.

The CPC is a group of Ken-Caryl Ranch residents and members from both the Master Association and Metropolitan District Boards of Directors that was tasked with evaluating the results of the survey and reporting back to both Boards with their recommendation on what the residents of Ken-Caryl Ranch want for the future of their

community. Based on this work over the past 18 months, the CPC is recommending the Metropolitan District consider asking voters this coming May to approve a bond issue of approximately \$7.9 million for improvements to the facilities and infrastructure of the community. The President of the Metropolitan District Board of Directors, Bob Generoli, has written a letter to residents, which appears on Page 3 of this issue of Life at Ken-Caryl, explaining more about this possible initiative.

To present specific information on a proposed May election asking voters to approve spending for improvements to the community and to answer questions from the voters, the Metropolitan District Board of Directors has scheduled two Community Meetings to explain and discuss the proposed improvements and the cost of the investment to homeowners on the following dates and times:

Wednesday, Feb. 5 at 7 p.m. at the Ranch House Saturday, Feb. 8 at 9 a.m. at the Ranch House

The meetings are designed to be a brief presentation followed by a question and answer period. Babysitting and refreshments will be provided. Getting The Most Out Of Your Paint Job

The annual paint review has been completed and soon those painting projects, along with many others, will be underway. Getting a great paint job on the exterior of your home is really important, so I thought it may be a great time to talk a little about exterior house painting.

There are a number of things to think about other than color when embarking on this project. I believe that the preparation work done prior to painting is extremely important to obtain the best results. If hiring a contractor, it may be wise to ask for a "tech data sheet" stating what surface preparation will be done such as: caulking, scraping, power washing and replacement of siding pieces if necessary. You will also want to know the quality of paint being used, number of coats and the method of application.

As with any work being done at your property, you want a contractor who does quality work and is honest, fair, neat and dependable. The Contractor Reference Book at the Ranch House and online may be helpful as it contains information provided by homeowners on Ken-Caryl Ranch who have had work done. Whoever you choose, be sure to ask for references and call those references.

Please keep in mind that rules and regulations are dynamic in nature...new issues surface, new regulations are added, inappropriate ones are deleted and others simply are amended or updated. Ken-Caryl Ranch documents are available at the Ranch House and on our website at www.ken-carylranch.org so try to make certain you, too, are up-to-date. Being Prepared For Winter In The Open Space

A change in the weather during warmer months can be a minor inconvenience, while being caught off guard in the winter has the potential for severe consequences. Always let someone know where you will be going and your estimated time of arrival back



home. Checking the forecast before going out can better prepare you for these conditions. Hiking, snowshoeing or skiing up steep foothill trails can be exhausting and cause you to work up a sweat even in frigid conditions. Dressing in layers can prevent overheating and allow you to better adapt to changing conditions.

The heat produced from exertion can be deceiving. If an extended stop is necessary due to an emergency or from exhaustion, the body can quickly become chilled and can lead to medical emergencies like hypothermia. Avoid wearing cotton clothing. Cotton takes a long time to dry and could lead to continual cooling of your core temperature. Wool base layers are a good choice during the winter because they have the ability to thermo regulate even when wet. By using finer wool fibers like merino wool, wool garments are less itchy and perform better than

the wool of old.

An extra layer like a wind shell can trap extra heat while sedentary, block the wind and can be easily packed away while on the move. The fine balance of exertion and your body's attempt to maintain a certain core temperature can burn a lot of calories. Bring plenty of water and high-energy foods on your winter outings. As we all know, the sun sets early in the winter months, so if you leave in the afternoon for your outing, give yourself plenty of time to return before dark.

Winter Essentials

- · Dress in layers. Lightweight, thermo-regulating base layers made of wool or synthetic fibers. Include a hat and gloves.
- Wind- and water-resistant shell.
- Plenty of high-calorie food and water.
- Survival kit with a fire starter, space blanket, whistle, first aid supplies and a source of light to navigate if you find yourself out in the dark.

Winter Trail Etiquette

- Get Muddy: As the snow melts, muddy sections develop on parts of the trails. Trail users should try to navigate through muddy sections, not around them. Circumventing muddy sections leads to widening of trail segments and a greater area of disturbance to the Open Space. When the trails are snow-packed, try to stay on the trail and avoid cutting switch backs. Using the trails during the early morning hours when the ground is frozen is a good alternative for those who aren't into getting muddy.
- Pets should be leashed and under the owner's control at all times. Even though it is hard to keep your pet leashed while using poles or when you decide to go to the local sledding area, the Open Space use rule No. 4 regarding leash regulations still applies. Coyotes and other predators may be more likely to approach pets that are loose and away from their owners when their normal food supplies are scarce. Dogs may be inclined to chase deer and other wildlife, when they are unleashed. Wildlife can use up their scarce energy reserves trying to flee from a loose pet. Harassment of wildlife is also a fineable offense under Colorado state law and can lead to an expensive citation. Other trail users will appreciate an under-control pet while they are navigating snowy terrain.

With proper preparation and adherence to a few simple guidelines, winter is a good time to get out and enjoy the trail system. If you have any questions regarding trail conditions or any Open Space matters, give the Ranger Staff a call at 303-904-0249.

Shoveling Sidewalks Serious Business

Dear Friends, Neighbors and Community Members,

The results of the Community Survey conducted in 2012 showed that the residents of Ken-Caryl Ranch (KCR) strongly support improving facilities and amenities throughout the Ranch. With interest rates at historic lows, the Ken-Caryl Ranch Metropolitan District (MD) Board of Directors, the Master Association (MA) Board of Directors and the Community Planning Committee are considering whether the community might benefit from a well-planned and managed investment that will upgrade and enhance our amenities while retaining their old west heritage and charm.

One option that is being considered is for the MD to include a bond issue ballot question in its May 2014 director election. If placed on the ballot and approved by KCR residents, proceeds from the bond issue would be used for renovations to the facilities and campuses at the Ranch House, the Community Center and Dakota Lodge, as well as improvements to playgrounds, parks, landscaping and irrigation. The MD Board of Directors is very interested in learning what you think about this financing option.

Our Facilities Are Aging

Many of the facilities, landscaping and infrastructure on Ken-Caryl Ranch are approaching 40 years of age. Over the years, these assets have been carefully maintained and renewed, within strict budgets, to preserve their original design and function. But just as our homes have needed some modernizing upgrades and changes, our key facilities have reached the point where new coats of paint cannot hide their age and outdated feel.

Maintaining The Ken-Caryl Ranch Quality Of Living & Property Values

During focus groups conducted in 2012, real estate agents who specialize in the south metro area reported that KCR's amenities and appearance suffer in comparison with newer neighborhoods, and that this problem will become more pronounced as development resumes in nearby areas such as Solterra, Sterling Ranch and Wildcat Ridge. These real estate professionals were concerned that, unless action is taken, KCR risks having the perception of being a community with fantastic open space but otherwise in decline. They feel that such a perception will limit the number of prospective homebuyers, and ultimately, our property values.

Modernizing and upgrading key facilities through some form of financing, such as a bond issue, will enable the MD to complete the improvements in three to five years. This will allow current residents and their families to enjoy the benefits of more modern and functional facilities, as well as the enhanced home values that improved amenities will bring.

How Tax-Exempt Municipal Bonds Work

Municipal bonds are issued by state and local governments ("municipalities") to raise money for major projects. First, a ballot question is presented to the voters asking for permission to issue bonds and raise taxes (such as property taxes) to repay the bonds. If approved by the voters, the local government sells the bonds to investors for a fixed amount of money and a specified amount of time, in exchange for regularly scheduled payments. Municipal bonds can be an attractive financing method because they typically carry interest rates that are below the going rate for other types of financing such as construction loans. The benefit to investors is that the earnings from the bonds are tax-exempt.

Should community feedback support the idea, the MD Board may include a ballot question in the May 2014 election asking residents to authorize the sale of tax-exempt municipal bonds to pay for specific facility improvements. The Board is considering a \$7.9 million bond issue to pay for those improvements, and further considering limiting the bonds to 10 years, so the property tax impact will be in effect for a short period of time. For each \$100,000 of market value, the expected cost would be about \$4 per month. For a \$400,000 house (the average value of a home on Ken-Caryl Ranch) the cost would be \$16 per month.

Saving vs. Financing

An alternative to financing the facility improvements would be for the MD to accumulate tax revenue to pay for the improvements. The MD Board's concern with this approach is that the MD's property tax revenue has dropped almost 17 percent over the last four years as a result of declining property values. Even if MD property tax revenues increase in the coming years, and the MA raises dues, it will take years for the MD to recover to its pre-2008 funding levels, and many additional years to save up enough money to pay for the needed improvements. Meanwhile, the cost of maintaining the existing facilities and paying for those deferred improvements will continue to increase.

You Have The Final Word

To provide time for public input, the MD Board will not make a final decision on whether to include a bond question in the May 2014 director election until early in March. In the meantime, the MD Board would greatly appreciate your input.

We will continue to provide additional information and details about the possible May Bond Election and planned improvements in upcoming issues of *Life at Ken-Caryl*, as well as via the website, *e-News* and Facebook.

Additionally, two Community Meetings have been scheduled to provide information, answer questions and gather your input. Each Honor Brick can have up to three lines of characters. There is enough room for 20 characters per line, and spaces count as a character. Text is limited to: Name, Rank, Branch of Service, Dates of Service or Campaign. There is a limited amount of clip art that has been approved. Anyone wanting clip art on their Honor Brick can select one from the samples shown on the Veterans Monument website at http://kcrveteransmon ument.wordpress.com. Each clip art will be two inches in size. Only one clip art is allowed per brick and will be located on the left side of the brick. Life at Ken-Caryl Celebrating 100 Years

How Things Have Changed: Forty Years Ago On The Ranch

What were you doing in 1974? That was the year that Hank Aaron claimed his 715th home run, Patty Hearst was kidnapped, *People Magazine* debuted and Richard Nixon resigned. Closer to home, in July, Ken-Caryl Ranch residential development kicked off with the initial offering of 10- to 25-acre lots for sale in the exclusive West Ranch.

Johns-Manville Corporation (J-M) bought the 10,000-acre Ken-Caryl Ranch in July 1971 from the McDannald family for \$7.5 million. W. Richard Goodwin, President and CEO of J-M, described the goal of the planned development was to balance the environment with an attractive lifestyle for residents. The 1972 Master Plan called for development to be limited to 2,300 acres, concentrated at the West Ranch, North Ranch and to the east of the Hogback in the Plains area. Commercial development, with the exception of the J-M World Headquarters, would remain east of the Hogback. Under this plan, most of the Valley side of Ken-Caryl Ranch would remain as


open space. J-M established the Ken-Caryl

Ranch Corp., to administer the Master Plan. J-M's move from New York City to Denver was based on economics, figuring that it was

less expensive to move 1,000 employees across the country and build a new headquarters than to attempt consolidating operations in Manhattan. Nine of the nation's leading architectural firms were invited to submit proposals for the new world headquarters. The Architects Collaborative of Cambridge, Mass., won the project and construction began in October 1973. Meanwhile, J-M operated out of the Research and Development Center (the current Johns-Manville property on W. Ute Ave.) completed in 1973. The plats for the first phase of the Plains development were filed in July 1974. The heart of the community was the planned Town Club (now known as the Ranch House complex). The first developers were M.J. Brock & Sons, who constructed the singlefamily homes at Aspen Meadows and Quail Ridge to the east and south of the Town Club, and Cotter-Orr Development Company who constructed the Settlement townhouses then thousands, of people with injury claims. J-M filed for Chapter 11 bankruptcy protection in August 1982. In reorganizing, J-M divested itself of various components of its holdings, including its interest in Ken-Caryl. In August 1987, Martin Marietta announced its intention of purchasing the J-M World Headquarters.

As we look back at 100 years of Ken-Caryl history, we are seeking people who lived in the Ranch in the 1970s and 1980s, and for photographs of the early, treeless, days of our community. Please contact Rose Lewis at 303-972-4576 if you are interested in sharing your Ken-Caryl story.

Editor's Note: What we know today as Ken-Caryl Ranch began on Oct. 17, 1914, with the purchase of 2,660 acres of land southwest of Denver by John Charles Shaffer. To recognize and commemorate 100 years of Ken-Caryl Ranch, Rosemary Lewis of the Historical Society will be writing articles in each issue of the paper noting historical events in and around Ken-Caryl Ranch. The series of articles will lead up to a celebration hosted by the Ken-Caryl Ranch Historical Society on Aug. 9 at the Manor House. The whole community is invited. 





Winter Coyote: The Season Of Love

Winter is courting season for coyotes so you may hear them more often as the lovelorn bachelors announce their locations and mated pairs reaffirm their partnerships.

Are you keeping your cats inside and your dogs on a leash? This is good advice any

time of the year, but especially during this active season. Let's take a moment to review what you may encounter during winter and what to do if you ever feel uncomfortable near a coyote.

You are walking your dog and encounter a coyote that looks at you and your dog and stands its ground. During mating season, coyotes may be interested in your dog as a mate. Mating between coyotes and dogs is possible but very uncommon. Dogs coming into a coyote's territory may also be seen as a threat. Walk your dog on a leash and give the coyote a wide berth.

A coyote is also a curious animal, so just because he stares at you or your dog is no cause for alarm. Chances are excellent that after curiosity is satisfied, the coyote will continue about his business of performing free pest control in your neighborhood.

If you see a coyote regularly in your neighborhood, even in broad daylight, what should you do? This coyote is coming to your neighborhood because it is finding easy food, water or shelter. Chances are that one of your neighbors is leaving pet food outside, or providing another easy meal. Who could resist a flurry of fat rodents attracted to birdseed on the ground or yummy, accessible garbage? The idea is not to roll out the red carpet for hungry coyotes but to remove attractants and scare the coyote away so that you can coexist peacefully.

If you are taking a walk in the open space and come upon a coyote that is uncomfortably close and does not move away, you can do yourself and the coyote a favor by teaching it to fear people. Yell at it, charge it waving your arms, throw rocks toward (not at) the covote, blow a whistle or pop open an umbrella. Do this "aversive conditioning" until the coyote retreats. Some coyotes have become comfortable around people. This is not good for the coyote, and they need to

learn to be wild again. However, if you see a coyote or group of coyotes in the distance, I hope you will feel comfortable enough to take time to enjoy the experience.





The Ken-Caryl Art Guild was organized in February 2004 for the purpose of education and development of artists on Ken-Caryl Ranch and surrounding communities. Business meetings preceded such varied programs as intuitive journaling, Feng Shui, and oil painting demo by Clyde Steadman, watercolor portraiture by Susan Montague, art marketing, printmaking, and so much more. Many of these presenters were hired by the Art Guild to present more comprehensive workshops, offered at no cost to the community. Favorite sessions included Eric Matelski's gel transfers, watercolors with Stan Miller, and a maskmaking workshop to prepare for the Guild's Annual Arti Gras fundraising parties.

In February 2005, 2006 and 2007, Guild members celebrated "Arti Gras" with a Mardi Gras event held at Deer Creek Golf Course that included an auction of handmade masks, original artwork, zydeco music and a Cajun buffet. Funds raised helped support Guild activities and a portion was donated to various causes - one of those being for education of art students in New Orleans after Hurricane Katrina. Since then, other worthy causes have benefited from members' generosity. Art supplies have been collected and donated to the Boys and Girls Club, and each year the Art Guild gives a monetary award to a participant in the Jeffco High School Student Art Exhibit held at the Arvada Center.

Artists don't just sit in their studios all day and create. They like to get out, too, so the Guild's Director of Art Appreciation is in charge of organizing outings for members and their guests. From First Friday on Santa Fe Drive to the Golden Triangle, Boulder's Open Studio Tours and a personal tour of Terry Ludwig's pastel factory, Art Guild members have had a lot of fun discovering new art-related venues to explore.

Ute Meadows Wins Money For Playground Improvements

Ute Meadows Elementary was selected as the winner of the Box Tops for Education "Super Cool School" Contest. Para educator Cindy Monroe entered Ute Meadows into the Box Tops contest and won \$75,921. The money will be used to make the school playground more accessible to the students in the Challenge Program, which is housed at the school for the area, and to upgrade the existing equipment. The Challenge Program offers special education and related services for students with severe developmental delays in multiple areas, such as cognitive, speech/language or motor delays.

Box Tops for Education is one of the nation's largest school fundraising loyalty programs and has been helping schools succeed since 1996. By clipping the small Box Tops coupon located on more than 250 participating products ranging from food to toiletries to clothing, it's an easy way for schools to earn cash for the things they need. Each Box Tops coupon is worth 10 cents. Schools can use their Box Tops cash to buy whatever they need most, from books to field trips to playgrounds.

"They asked for 200 words on what we would do with the money if we won," said Cindy. "So, I told them we have a number of Challenge students in wheelchairs and limited mobility who can't access our playground, and we would use some of the money to make our current playground handicap accessible for all of our students."

Those words won the school \$75,000, in addition to the \$921 from clipping Box Tops. Cindy said the school collects Box Tops yearround and typically earns \$1,500 a year, but this prize tops them all. "We still get families whose children have grown and moved on from Ute still dropping off Box Tops to our school," she said.
