Metropolitan District Mill Levy Increase Defeated by Voters



The Ken-Caryl Ranch Metropolitan METROPOLITAN DISTR District Ballot Issue 6G Mill Levy increase was defeated by voters in the November 2018 election. Election results:

In Favor: 2,286 (34 percent) Opposed: 4,396 (66 percent)

Master Association Board Adopts 2019 Budget with \$1 Dues Increase

The Master Association Board

adopted the 2019 budget on Wednesday, Nov. 7. The budget includes a \$1 monthly dues increase, making the 2019 dues:

- \$53 per month for residential properties
- \$41 per month per apartment unit
- \$37 per month per acre for commercial properties
