Metropolitan District Budget and Pool Fee Discussion

The Ken-Caryl Ranch Metropolitan District Board adopted the 2019 budget at its meeting on Dec. 4. Due to public input, the Board decided not to charge pay-per-use pool fees in 2019. However, a target amount of \$55,000 for revenue and cost savings from pools was set. Staff presented ideas such as

rotating pool schedules, a pool pass verification administrative fee, and/or adjusting pool hours. Community input will be sought in 2019 to determine how to generate the revenue and save on expenses. Click the link below to read a summary of the budget.

Residents of KCR will still be able to use Foothills facilities as they are all open to the public but will pay non-resident fees starting Jan. 1, 2019.


Caryl Equestrian Center! The rides are for ages 3 to 100 (you're never too old for a pony ride), and the cost is \$30, payable with cash


