Please note that both the Ranch House and the Community Center will be closed on Thursday, Nov. 23 for the Thanksgiving holiday.



MA Board Adopts 2024 Budget with a \$4 Dues Increase

The Ken-Caryl Ranch Master Association Board adopted the 2024 Budget at its Nov. 14 meeting. There will be a \$4 per month dues increase in 2024, effective Jan. 1,

2024. This will bring the total monthly dues amount to \$68 for single family homes. The increase is needed for increased operational expenses, continued fire mitigation efforts, and a continued focus on perimeter fence improvements and asset maintenance.
